III. BACKGROUND:

Failure to Timely File Reports and Chronic Late Filing of Reports

The Nevada State Republican Central Committee ("the Committee") has failed to file fifteen (15) Reports of Receipts and Disbursements in a timely manner for the 1995-1996 election cycle (see attached chart). The reports were filed between twenty-three (23) and two-hundred-forty-five (245) calendar days late. The Committee was notified on December 28, 1994 that all 1995 Monthly reports were due on the twentieth day of each month in 1995 (Attachment 2).

On March 13, 1995, the Reports Analysis Division ("RAD") analyst called and left a message with the Committee Treasurer, Mr. Bob Beers stating that the 1994 Year End Report and the 1995 February Monthly Report had not been received at the Commission and needed to be filed as soon as possible (Attachment 3).

* At various times, there were vacancies in the office of treasurer. In addition, some Nonfiler Notices were sent to the Committee's former address of record.

On March 14, 1995, a Nonfiler Notice was sent for failure to file the 1995 February Monthly Report (Attachment 4).

On March 16, 1995, the RAD analyst called Mr. Beers again. His secretary relayed the message that Mr. Beers had resigned as the Committee Treasurer, but was intending to file the reports soon. The analyst left a message for Mr. Beers stating that the Committee should notify the Commission of the change in treasurer and file the 1994 Year End Report and 1995 February Monthly Report as soon as possible (Attachment 5).

On April 12, 1995, a Nonfiler Notice was sent for failure to file the 1995 March Monthly Report (Attachment 6).

On April 17, 1995, the Commission was notified in writing that Mr. Beers had resigned as the Committee Treasurer and no replacement had been selected (Attachment 7).

On May 4, 1995, the RAD analyst called Mr. Beers and left him a message that the 1994 Year End Report, 1995 February, 1995 March and 1995 April Monthly Reports had not been received at the Commission and it was very important to file these reports as soon as possible. (Attachment 8).

On May 9, 1995, Mr. Beers' secretary called the RAD analyst to relay the message that Mr. Beers had resigned as the Treasurer of the Committee and a replacement had not been named yet. The RAD analyst reiterated that the necessary reports still had not been filed and left a message for Mr. Beers to contact the analyst (Attachment 9).

On May 16, 1995, Mr. Beers called the RAD analyst and indicated that he had resigned as the Committee Treasurer, but was still working on the reports. The analyst urged Mr. Beers to file all delinquent reports as soon as possible and to file future reports in a timely manner. (Attachment 11).

On June 9, 1995, a Nonfiler Notice was sent for failure to file the 1995 May Monthly Report (Attachment 12).

On June 21, 1995, Mr. Robert S. Bingham called the analyst and introduced himself as the new Committee Treasurer. The analyst notified him that the Committee had not filed any 1995 Monthly Reports. The analyst stressed the importance of filing these reports as soon as possible and of filing future reports in a timely manner. The analyst urged Mr. Bingham to notify the Commission in writing of the treasurer change. At this time Mr. Bingham indicated that the Committee was having difficulty securing Committee

records from Bob Beers, the previous treasurer, and that they would file all the 1995 Monthly Reports as soon as they could be prepared (Attachment 13).

On June 26, 1995, the Commission was notified in writing that Mr. Robert S. Bingham had been elected as the new Committee Treasurer (Attachment 14).

On July 12, 1995, a Nonfiler Notice was sent for failure to file the 1995 June Monthly Report (Attachment 15).

On August 7, 1995, the Commission was notified in writing that Mr. Bingham had resigned as the Committee Treasurer and the Assistant Treasurer, Mr. Mark Alden, was completing the delinquent reports (Attachment 16).

On August 11, 1995, a Nonfiler Notice was sent for failure to file the 1995 July Monthly Report (Attachment 17).

On August 31, 1995, Bob Beers called the analyst and said that he had been re-elected as the Treasurer of the Committee and was planning to file the 1995 Monthly Reports soon. The analyst stressed the importance of filing these reports right away. The analyst also urged the Committee to file all future reports in a timely manner (Attachment 18).

On September 5, 1995, the Committee filed only the 1995 February Monthly Report and notified the Commission in writing that Mr. Beers had been re-elected as the Committee Treasurer (Attachment 19).

On September 8, 1995, a Nonfiler Notice was sent for failure to file the 1995 August Monthly Report (Attachment 20).

On October 10, 1995 and November 13, 1995, the analyst called Mr. Beers after Nonfiler Notices had been sent October 10th and November 8th for failure to file the 1995 September and October Monthly Reports, respectively (Attachments 22 and 23). The analyst left messages that the Committee's reports still had not been received at the Commission (Attachment 21).

On November 20, 1995, the Committee filed the 1995 March Monthly, 1995 April Monthly, 1995 May Monthly, 1995 June Monthly and 1995 July Monthly Reports (Attachments 24 through 28).

On December 12, 1995, a Nonfiler Notice was sent for failure to file the 1995 November Monthly Report (Attachment 29). On December 29, 1995, the Committee was notified that the 1995 Year End Report was due on January 31, 1996 and the 1996 February, March and April Monthly Reports were due on

the twentieth day of February, March and April, respectively (Attachment 30).

On January 16, 1996, a Nonfiler Notice was sent for failure to file the 1995 December Monthly Report (Attachment 31).

On January 26, 1996, a Chronic Late Filer Notice was sent to the Committee for failing to file the 1995 February, 1995 March, 1995 April, 1995 May, 1995 June, 1995 July, 1995 August, 1995 September, 1995 October, 1995 November and 1995 December Monthly Reports in a timely manner (Attachment 32). The Notice advised the Committee that any additional late filing of reports may result in legal enforcement action.

Subsequent to the sending of the Chronic Late Filer Notice, the Committee failed to timely file the 1995 Year End, 1996 February, 1996 March and 1996 April Monthly Reports.

On February 20, 1996, the Commission was notified in writing that new officers had been elected and the Committee expected to file the required reports soon (Attachment 33). The analyst called Ellen Mai, Finance Director, to get information about the new treasurer. Ms. Mai said that Bob Beers would be finishing up the reporting problems and then the job would pass on to a newly-elected Treasurer. The analyst stressed the importance of filing the delinquent reports as soon as possible and asked her to please update the Commission on the treasurer information (Attachment 34).

On February 23, 1996, a Nonfiler Notice was sent for failure to file the 1995 Year End Report (Attachment 35). The Committee filed its 1995 August Monthly Report on March 1, 1996 (Attachment 36). On March 12, 1996, a Nonfiler Notice was sent for failure to file the 1996 February Monthly Report (Attachment 37). The Committee filed its 1995 September Monthly Report on April 1, 1996 (Attachment 38).

On April 3, 1996, the analyst called Bob Beers and left a message for him to return the call regarding the late-filing of reports. Mr. Beers did not return the phone call (Attachment 39).

On April 9, 1996, a Nonfiler Notice was sent for failure to file the 1996 March Monthly Report (Attachment 40).

On May 8, 1996, the analyst was contacted by Mr. Dan Burdish, the new Executive Director of the Committee and the point of contact at the Committee office. He introduced himself and provided information on the new Treasurer, Ronald F. Ryan. Mr. Burdish inquired about the status of the

Committee and expressed the intention on the new officers' part to file all the delinquent 1995 Monthly Reports as soon as possible and to file all future reports in a timely manner. The analyst reiterated the importance of this to the Committee (Attachment 41).

The Committee filed the 1995 October and 1996 February, March and April Monthly Reports on May 13, 1996 (Attachments 42 through 45). An amended Statement of Organization was filed on May 16, 1996 naming Ronald F. Ryan as Treasurer (Attachment 46). On May 28, 1996, the Committee filed its 1995 November and December Monthly Reports followed on June 6, 1996 with its 1995 Year End Report (Attachments 47 through 49).

The Committee has since filed the 1996 May, 1996 June, 1996 July, 1996 August, 1996 September and 1996 October Monthly Reports, and the 1996 12 Day Pre-General Report in a timely manner.
