Dear Mr. McGarry:

I serve as counsel to the Republican Party of Nevada, respondent in the above-referenced matter. (The Statement of Designation of Counsel is enclosed for your files.) As such, your letter dated April 29, 1997, to Ronald F. Ryan (Treasurer of the Nevada State Republican Central Committee) was referred to me for a response. I have had an opportunity to review your letter, the Factual And Legal Analysis prepared by your office, and the proposed Conciliation Agreement with my client and offer the following response.

First, the Republican Party of Nevada neither materially disputes nor challenges the substantive Factual And Legal Analysis. It recognizes that during the time period in question, there was a lack of both communication and continuity between those individuals who held the office of Treasurer. While not excusable, we can assure you that any failures to strictly comply with the Federal Election Campaign Act and related statutes was unintentional. The Republican Party of Nevada has taken both extreme and expensive measures to ensure that violations such as the ones alleged do not occur in the future. In fact, a review of the Party's filings over the past 14 months reveals that all monthly reports have been timely filed and there has been a timely response to all requests for amendments and clarifications.




