We have received your letter of January 4, 2000, executed on your behalf by Associate General Counsel Lois Lerner, which advises of the closing of the file with respect to complaint of Carol J. Lewis (MUR 4646) alleging illegal contributions to Friends of Jane Harman.

We were pleased to note that this matter has been resolved "with no Commission findings having been made against your clients" (the Harman respondents). We also understand, however, that the Commission requires the refund of all illegal contributions even in cases such as this, where the Harman Committee did not know – and the Commission has found that it did not know – that the contributions were illegal in origin.

Accordingly, pursuant to this rule and in accordance with the request made in your January 4 letter, the Harman Committee herewith forwards a check to the United States Treasury in the amount of \$4,000, representing four contributions dated May 23, 1996 from Rhea Weil, Lawrence Herman, Wallace Walker and Carol J. Lewis.
