III. BACKGROUND:

Failure to File Forty-Eight Hour Notifications

Zimmer for Senate, Inc. ("the Committee") has failed to file 48-Hour Notifications ("48-Hour Notices") for contributions totaling \$39,500 received prior to the 1996 General Election.

The candidate was involved in the 1996 General Election held on November 5, 1996. Prior Notice was sent to the Committee on September 30, 1996 (Attachment 2). The Notice includes a section titled "48 Hour Notices on Contributions". This section reads "Notices are required if the committee receives contributions (including in-kind gifts or advances of goods or services; loans from the candidate or other non-bank sources; and guarantees or endorsements of loans to the candidate or committee) of \$1,000 or more, during the period of October 17 through November 2. The notices must reach the appropriate federal and state filing offices within 48 hours of the committee's receipt of the contribution(s)."

Schedules A of the 1996 30 Day Post-General Report indicate that the Committee has failed to file 48-Hour Notices for contributions received during the aforementioned period (Attachment 3). The following are the contributions, as reported by the Committee, for which 48-Hour Notices have not been filed:

¹ These contributions were initially received on October 17, 1996 by Team Victory '96, a joint fundraising committee. The Committee filed a 48-Hour Notice on October 19, 1996 which reported the receipt of a \$2,425.01 transfer from Team Victory '96 on October 18, 1996; however, neither the Committee nor Team Victory '96 filed a 48-Hour Notice for the two (2) contributions themselves.

On February 7, 1997, a Request for Additional Information ("RFAI") was sent to the Committee (Attachment 4). The RFAI notes on an informational basis that the Committee may have failed to file one or more of the required 48-Hour Notices for "last minute" contributions of \$1,000 or more. The notice requests the Committee to review their procedures for checking contributions received during the aforementioned time period. In addition, the notice states that although the Commission may take legal steps, any response would be taken into consideration.

On March 21, 1997, the Committee sent a letter stating it needed more time to respond to the RFAI dated February 7, 1997, in addition to other RFAs sent by the Commission. The treasurer stated a response would be forwarded by April 1, 1997 (Attachment 5).

The Committee's response received April 2, 1997 does not adequately address the failure to file 48-Hour Notices for the \$39,500 in contributions. (Attachment 6).

The Committee's response received April 14, 1997 addresses their failure to file 48-Hour Notices (Attachment 7). First, the Committee states that the contributor, Jay Bernstein, was reported on the 48-Hour Notice as part of the contribution received from Team Victory '96. Second, the Committee has provided a copy of the 48-Hour Notices fax acknowledgment of receipt sheet dated October 22, 1996 from the Office of Public Records of the United States Senate. The fax acknowledgment of receipt sheet indicates that only one page was received; however, five pages are attached. The Committee indicates that it appears that "through some technical error" that the Commission did not receive all of the pages of this report. Third, the Committee states that they were unable to find the receipt for the three pages of 48-Hour Notices filed 10/23/96, but that they "assume some technical error prevented this report from being put on the public record by the FEC."

If the campaign has an authorized committee(s), in addition to the principal campaign committee, the principal campaign committee must also file a consolidated report on Form 32 and attach the report(s) of the authorized committee(s).

48 HOUR NOTICES ON CONTRIBUTIONS

Notices are required if the committee receives contributions (including in-kind gifts or advances of goods or services; loans from the candidate or other non-bank sources; and guarantees or endorsements of loans to the candidate or committee) of \$1,000 or more, during the period October 17 through November 2.

The notices must reach the appropriate federal and state filing offices within 48 hours of the committee's receipt of the contribution(s). U.S. House candidates faxing 48-hour notices should transmit them to the FEC at 202/219-0174. Senate candidates should transmit them to the Secretary of the Senate at 202/224-1831. Note that 48-hour notices are the only FEC documents that may be faxed.

LABEL

Committees should affix the peel-off label from the envelope to Line 1 of the report. Corrections should be made on the label.

COMPLIANCE

Treasurers of political committees are responsible for filing all reports on time. Failure to do so is subject to enforcement action. Committees filing illegible reports or using non-FEC forms (except for FEC approved computer generated forms) will be required to refile.

*These dates indicate the beginning and the end of the reporting period. A reporting period always begins the day after the closing date of the last report filed. If the committee is new and has not previously filed a report, the first report must cover all activity that occurred before the committee registered and, if applicable, before the individual became a candidate.

**Reports sent registered or certified mail must be postmarked by the mailing date; otherwise, they must be received by the filing date.



I. GENERATION OF MATTER

The Office of General Counsel received a referral from the Reports Analysis Division ("RAD") on June 9, 1997. The basis for the referral is the failure of Zimmer for Senate, Inc., and David Millner, as treasurer ("Respondents") to file thirty-four 48 Hour notifications ("48 Hour Notices") for contributions totaling \$39,500. Dick Zimmer lost the 1996 General Election for the Senate in New Jersey receiving forty-three (43%) of the vote.

II. FACTUAL AND LEGAL ANALYSIS

Based on the Factual and Legal Analysis, see Attachment 1, this Office recommends the Commission find reason to believe Zimmer for Senate, Inc., and David Millner, as treasurer violated 2 U.S.C. § 434(a)(6)(A).

III. DISCUSSION OF CONCILIATION AND CIVIL PENALTY

This Office also recommends that the Commission offer to enter into conciliation with the Respondents prior to a finding of probable cause to believe. Attached for the Commission's approval is a proposed conciliation agreement.

On November 6, 1997, the Federal Election Commission found that there is reason to believe that Zimmer for Senate, Inc., and you, as treasurer, violated 2 U.S.C. § 434(a)(6)(A), a provision of the Federal Election Campaign Act of 1971, as amended. The Factual and Legal Analysis, which formed a basis for the Commission's finding, is attached for your information.

You may submit any factual or legal materials that you believe are relevant to the Commission's consideration of this matter. Please submit such materials to the General Counsel's Office within 15 days of your receipt of this letter. Where appropriate, statements should be submitted under oath. In the absence of additional information, the Commission may find probable cause to believe that a violation has occurred and proceed with conciliation.

In order to expedite the resolution of this matter, the Commission has also decided to offer to enter into negotiations directed towards reaching a conciliation agreement in settlement of this matter prior to a finding of probable cause to believe. Enclosed is a conciliation agreement that the Commission has approved.

If you are interested in expediting the resolution of this matter by pursuing pre-probable cause conciliation and if you agree with the provisions of the enclosed agreement, please sign and return the agreement, along with the civil penalty, to the Commission. In light of the fact that conciliation negotiations, prior to a finding of probable cause to believe, are limited to a maximum of 30 days, you should respond to this notification as soon as possible.

Requests for extensions of time will not be routinely granted. Requests must be made in writing at least five days prior to the due date of the response and specific good cause must be demonstrated. In addition, the Office of the General Counsel ordinarily will not give extensions beyond 20 days.

If you intend to be represented by counsel in this matter, please advise the Commission by completing the enclosed form stating the name, address, and telephone number of such counsel, and authorizing such counsel to receive any notifications and other communications from the Commission.

This matter will remain confidential in accordance with 2 U.S.C. §§ 437g(a)(4)(B) and 437g(a)(12)(A), unless you notify the Commission in writing that you wish the investigation to be made public.

For your information, we have attached a brief description of the Commission's procedures for handling possible violations of the Act. If you have any questions, please contact Eugene Bull, the staff member assigned to this matter, at (202) 219-3690.

This matter was generated based on information ascertained by the Federal Election Commission ("the Commission") in the normal course of carrying out its supervisory responsibilities. See 2 U.S.C. 437g(a)(2).

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires principal campaign committees of candidates for federal office to notify in writing either the Secretary of the Senate, or the Commission, as appropriate, and the Secretary of State of the appropriate state, of each contribution totaling \$1,000 or more, received by any authorized committee of the candidate after the 20th day but more than 48 hours before any election. 2 U.S.C. § 434(a)(6)(A). The Act further requires notification to be made within 48 hours after the receipt of the contribution and to include the name of the candidate and office sought, the date of receipt, the amount of the contribution, and the identification of the contributor. Id. The notification of these contributions shall be in addition to all other reporting requirements. 2 U.S.C. § 434(a)(6)(B).

Zimmer for Senate, Inc. ("the Committee"), was the authorized campaign committee for Dick Zimmer's 1996 campaign for the Senate in New Jersey. On September 30, 1996, the Commission sent a notice to the Committee regarding the 48 hour reporting requirements. The 1996 General Election was held on November 5, 1996. Pursuant to the Act, the Committee was required to notify the Secretary of the Senate, in writing, of all contributions of \$1,000 or more

received from October 17, 1996 through November 2, 1996, within 48 hours of their receipt. A review of the Committee's 1996 30 Day Post-General Report and 48-Hour Notices on file with the Commission identified thirty-four (34) contributions received between October 17, 1996 and November 2, 1996, of \$1,000 or more, and totaling \$39,500, for which the Committee did not file 48-Hour Notices.

Therefore, there is reason to believe that Zimmer for Senate, Inc., and David Millner, as treasurer, violated 2 U.S.C. § 434(a)(6)(A) by failing to report campaign contributions of \$1,000 or more, received after the 20th day, but more than 48 hours before the 1996 General Election, within 48 hours of receipt of the contributions.

Dear Mr. Bull:

In response to the Commission's recent finding and proposed Conciliation Agreement, Respondents in the above-captioned matter submit the attached, revised Conciliation Agreement. For the reasons set forth in this letter, Respondents believe the Federal Election Commission's ("Commission") Agreement is inconsistent with not only the facts of this case but also the Commission's own precedents in similar enforcement matters. Accordingly, Respondents respectfully request that, after reviewing these materials, the Commission agree to Respondents' revised Conciliation Agreement.

I. Factual Discussion

Respondents believe that the Commission is factually incorrect in its core finding that the Zimmer for Senate Committee did not file 48-hour notices for 34 contributions totaling \$39,500.

While the Commission did not include a list of these alleged omissions, a review by the Committee reaches a far different conclusion. The Committee maintains that it consistently followed its standard procedures of filing 48-hour reports for all contributions of \$1,000 or more. Affidavit of David Millner ("Millner Aff.") ¶¶ 2, 3. Indeed, it is uncontroverted that the Committee filed a total of 405 48-hour contributions totaling \$338,925 on six reports, demonstrating a policy and pattern of complying with the reporting requirements. The Committee's treasurer further states in his sworn affidavit that it is his "firm belief that all 48-hour reports were sent as required to the Secretary of the Senate and it was certainly our intention to send everything required by the law." Millner Aff. ¶ 3.

As best as the Committee can determine without any specific information from the Commission, at issue appear to be the 48-hour reports for the dates of October 22 and October 23, 1997. Attached is the report for October 22, along with the receipt from the Secretary of the Senate. Mr. Millner believes that, pursuant to the Committee's procedures, the entire report was sent, Millner Aff. ¶ 4, although the Commission's records show the receipt of only one page of the five page report (attachment A). This first four pages of the report contained 20 contributions totaling \$21,500 (the page that is on file shows contributions of \$3,000).

Mr. Millner also believes that the Committee sent the 48-hour report for October 23, Millner Aff. ¶ 6, but the Committee has no receipt for this transmission. The report includes

12 contributions totaling \$16,000. The Committee had a system in place to send this report; the Committee sent all other required 48-hour reports, and this \$16,000 worth of contributions is unremarkable in a highly-publicized campaign that spent over \$8,200,000.

In sum, the Committee submits that any errors involving the filing of the 48-hour report for October 22 are not its own. The Committee further submits that although it has no corresponding receipt, its standard operating procedures would have produced a report for October 23. As such, the most that is at issue appears to be 12 contributions totaling \$16,000 that appear on the October 23 report.

Accordingly, at worst, the Committee inadvertently forgot to transmit one 48-hour report with 12 contributions totaling \$16,000. The Committee filed longer 48-hour reports containing more contributions and larger dollar amounts both in the days before and days after the reports at issue. Yet the Commission proposes a penalty that is strikingly inconsistent with its own precedents. The highly punitive penalty proposed here comes despite the Respondents' otherwise complete compliance with the Federal Election Campaign Act ("Act"), including correctly reporting the very contributions that are now at issue on its post-election report.

Indeed, in light of the penalty proposed by the Commission, it is important to remember what this case is not about. This case is not about a campaign that willfully or knowingly failed to comply with the Act and its reporting requirements. This case is not about a campaign that viewed violations of the Act as a "cost of doing business." This case is not about a campaign that

repeatedly failed to comply with reporting requirements. This case is not about a campaign that ignored or failed to become familiar with the Act. This case is not about a campaign that deserves to be targeted for a punitive fine by the Commission.

Rather, the Committee and its treasurer, David Millner, meticulously and diligently complied with all the Act's relevant reporting requirements. As a matter of policy and practice, with one possible unintentional exception, the Respondents complied fully with the Act's 48-hour notification rule. Such attention to detail and dedication to full compliance is evidenced by the Committee's near flawless record of satisfying the 48-hour reporting rules. In fact, during the primary and general elections, it is uncontroverted that all but a minuscule percentage of the contributions that were subject to the 48-hour requirements were properly reported. Even if there was an inadvertent oversight regarding one report, this isolated instance is not large or significant given the otherwise flawless record of compliance and disclosure.

Moreover, any factual basis for the Commission's finding is the complete and accurate disclosure of those contributions on the Committee's post-election report. This shows the inadvertent nature of any omission that may have occurred and the overall goal of complete compliance that characterized the Committee's reporting. Penalties such as one the sought here may be appropriate when the Commission can show an intent to deprive the voters or the Commission of any information relating to the campaign. But that is not the case here. This voluntarily disclosed information that the Committee offered in an effort to comply fully with the

Act is now being unjustly used as the basis of the Commission's complaint. Such use of voluntarily submitted information to penalize a Committee that acted in good faith and took every possible step to comply with the Act is in direct contradiction of the Commission's stated enforcement policy of promoting voluntary compliance by focusing its prosecutorial efforts on cases involving a knowing, willful or serious intent to violate the Act. This is clearly not such a case.

Another mitigating factor in this case is that this alleged inadvertent mistake does not trigger any of the factors that the legislative history shows were the reasons for the 48-hour requirement. According to the Act's legislative history, the primary purpose behind the 48-hour rule is to assure the public that special interests were not exercising "undue influence upon the Nation's legislators" and "to make campaigns fair and honest." Sen. Rep. No. 92-96, 92d Cong., 2d Sess. 2 (1972), reprinted in 2 U.S. Cong. & Admin. News, *Legislative History of the Federal Election Campaign Act of 1971* at 1861 (1972). The small amount of the contributions in question are not from a special interest group whose support of a candidate is crucial information for the voters to have prior to making their decisions.

Despite these overwhelming mitigating factors, the Commission now brings this action seeking a punitive fine of a disproportionate and unjustified magnitude in relation to prior Commission fines concerning the 48-hour reporting requirement. It is simply inappropriate and counterproductive to so harshly penalize a campaign that: (1) obviously had no knowing or

The bottom line is that the Respondents should not bear a penalty of this magnitude, which is appropriate only for those who willfully or repeatedly violate the Act or treat non-compliance as a mere cost of doing business. If Respondents are punished more than or the same as campaigns that habitually or intentionally fail to comply, but happen to involve smaller dollar amounts, then the Commission is acting contrary to its stated enforcement policy based on "prosecutorial discretion." Indeed, if the Commission fails to distinguish between habitual non-compliers and campaigns that make just one mistake, it is difficult to see how the Commission reaches its goal of having regulated entities voluntarily comply with the law, or having the public believe the Commission is fairly exercising "prosecutorial discretion." Similarly, if the mitigating factors described herein are ignored and Respondents are treated the same as another campaign with the same dollar amount involved irrespective of the underlying circumstances, the Commission is following an arbitrary and capricious policy.

As the following Legal Analysis will demonstrate, this case does not warrant the penalty sought here.



3. It is my firm belief that all 48-hour reports were sent as required to the Secretary of the Senate and it was certainly our intention to send everything required by the law.







On November 6, 1997, the Commission found reason to believe that Zimmer for Senate Inc. and David Millner, as treasurer (the "Committee" or "Respondents") violated 2 U.S.C. § 434(a)(6)(A). The reason to believe finding was based on the Committee's failure to file thirty-four 48 Hour Notifications for contributions totaling \$39,500. In order to expedite the resolution of the matter, the Commission also decided to enter into preprobable cause conciliation with Respondents.

The General Counsel's Office notified Respondents of the Commission's reason to believe finding on November 12, 1997. However, the notification letter was returned because Respondents apparently had changed their business address some time earlier without notifying the Commission of the change of address. On December 11, 1997, the General Counsel's Office resent the notification letter to Respondents. Counsel for the Committee subsequently requested an extension to January 9, 1998, to prepare a response to the reason to believe finding. This Office received the Committee's response and counteroffer on January 9, 1998 (Attachment 1)

For the reasons discussed below, we recommend that the Commission reject the Committee's



If you are unable to file a responsive brief within 15 days, you may submit a written request for an extension of time. All requests for extensions of time must be submitted in writing



GENERAL COUNSEL'S BRIEF

I. STATEMENT OF THE CASE

On November 6, 1997, the Commission found reason to believe that Zimmer for Senate Inc., and David Millner, as treasurer (the "Committee" or "Respondents") violated 2 U.S.C. § 434(a)(6)(A). The reason to believe finding was based on the Committee's failure to file thirty-four 48 Hour Notifications for contributions totaling \$39,500 in connection with the 1996 campaign for the Senate in New Jersey.

II. ANALYSIS

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires principal campaign committees of candidates for federal office to notify in writing either the Secretary of the Senate, or the Commission, as appropriate, and the Secretary of State of the appropriate state, of each contribution totaling \$1,000 or more, received by any authorized committee of the candidate after the 20th day but more than 48 hours before any election. 2 U.S.C.

§ 434(a)(6)(A). The Act further requires notification to be made within 48 hours after the receipt of the contribution and to include the name of the candidate and office sought, the date of receipt, the amount of the contribution, and the identification of the contributor. *Id.* The notification of these contributions shall be in addition to all other reporting requirements.

2 U.S.C. § 434(a)(6)(B).

On September 30, 1996, the Commission sent a notice to Zimmer for Senate regarding the 48 hour reporting requirements. Since the 1996 General Election for the Senate in New Jersey was held on November 5, 1996, pursuant to the Act, the Committee was required to notify the Secretary of the Senate, in writing, of all contributions of \$1,000 or more received from October 17, 1996 through November 2, 1996, within 48 hours of their receipt. A review of the Committee's 1996 30 Day Post-General Report and 48-Hour Notices on file with the Commission identified thirty-four (34) contributions received between October 17, 1996 and November 2, 1996, of \$1,000 or more, and totaling \$39,500, for which the Committee did not file 48-Hour Notices. Attachment 1.

Respondents admit to only \$16,000 of these unreported contributions, primarily on the basis of their treasurer's "firm belief that all 48-hour reports were sent." They also insist that they filed five pages of contributions as their October 22, 1996 48 Hour Report, even though the available evidence contradicts this claim. The fax machine at the Senate Secretary's Office confirmed that only one page of contributions was filed. Also, the Commission's records show that the Committee did not file an October 23, 1996 48 Hour Report; this is consistent with Respondent's inability to find a receipt verification for the report they claim was filed on that date. Therefore, Respondents' belief that they filed the required 48 Hour Reports is not consonant with the facts of this matter.

While the Committee reported two of the thirty-four contributions within the required 48 hours as part of a receipt from a joint fundraising committee, the Act's 48 Hour reporting requirements were not satisfied. As reported, there was no information about who made the two


contributions and in what amounts. In contrast, Section 434(a)(6)(A) requires the reporting of both the amount of the individual contribution and the identity of the contributor.

III. GENERAL COUNSEL'S RECOMMENDATION

1. Find probable cause to believe that Zimmer for Senate, Inc., and David Millner, as treasurer violated 2 U.S.C. § 434(a)(6)(A).

RESPONDENT'S REPLY TO GENERAL COUNSEL'S BRIEF

Zimmer for Senate, Inc. and David Millner, as treasurer, ("Committee" or collectively "Respondents") by and through the undersigned counsel, hereby reply to the General Counsel's Brief in the above-captioned matter. For the foregoing reasons, Respondents respectfully request that the Commission reject the General Counsel's recommendation to find probable cause.

I. STATEMENT OF THE CASE

On November 6, 1997, the Commission, based on the General Counsel's conclusory (and erroneous) Factual and Legal Analysis,¹ found reason to believe that Respondents violated 2 U.S.C. § 434(a)(6)(A) (regarding 48-hour notices). In an effort to resolve the matter expeditiously, Respondents requested pre-probable cause conciliation, and submitted a proposed conciliation agreement that was consistent with the Commission's own precedents in similar enforcement matters. See Respondents' Letters of January 9, 1998 and February 2, 1998.

¹ The Factual and Legal Analysis failed to provide any specifics, such as the date of the alleged violations. Instead, it rested only on the following conclusory allegation: "A review of the Committee's 1996 30 Day Post-General Report and 48-Hour Notices on file with the Commission identified thirty-four (34) contributions received between October 17, 1996 and November 2, 1996, of \$1,000 or more, and totaling \$39,500, for which the Committee did not file 48-Hour Notices." Factual and Legal Analysis at 2. As discussed in this Reply, such allegations are incorrect.

The General Counsel has now recommended that the Commission find probable cause.

This matter centers around the allegation that Respondents failed to file 48-hour notices for thirty-four (34) contributions of \$1,000 or more (totaling \$39,500), received between October 17, 1996 and November 2, 1996. Specifically, the General Counsel questions Respondents' 48-hour reports of October 22 and 23, 1996, and the source of two other contributions. See General Counsel's Brief, Attachment 1.

Of course, it is uncontroverted that Respondents filed a total of 405 48-hour notices for contributions totaling \$338,925 on six reports, thereby demonstrating a policy and pattern of complying with the reporting requirements. The Committee's treasurer has stated (in a sworn affidavit) that it is his "firm belief that all 48-hour reports were sent as required to the Secretary of the Senate and it was certainly our intention to send everything required by the law." Millner Aff. ¶ 3. The candidate lost the election at issue, and is not currently seeking public office.

II. LEGAL ANALYSIS

The General Counsel's Brief is wrong on both the facts and the law. First, the Brief is factually incorrect in its assertion that "Respondents admit to only \$16,000 of these unreported contributions" General Counsel's Brief at 2. Respondents have not admitted this.

Nor do the General Counsel's accusations (albeit inferential) regarding the October 22, 1996 report ring true. Instead, the facts are these:

- Respondents spent well over \$8,200,000 in the campaign, of which a mere \$39,500 is at issue.
- The Committee's treasurer has stated under oath his belief that the Committee sent the 48-hour report for October 22, 1996 (which includes 20 contributions totaling \$21,500). Millner Aff. ¶¶ 3.
- The Committee retained the confirmation receipt for this transmission (although it indicates a successful transmission of only one page of the report). General Counsel's Brief at 2.
- The Committee's treasurer has stated under oath his belief that the Committee sent the 48-hour report for October 23, 1996 (which includes 12 contributions totaling \$16,000). Millner Aff. ¶¶ 6.
- Although the Committee does not have a confirmation receipt for this facsimile transmission, the Committee had a system in place to send this report. Millner Aff. ¶ 2.
- The Committee Respondents filed a total of 405 48-hour notices for contributions totaling \$338,925 on six reports, thereby demonstrating a policy and pattern of complying with the reporting requirements. Respondents' Letter of January 9, 1998 at 2.
- The campaign at issue was well-publicized, so that even if Respondents had not complied with the Act, the value of the information missing is negligible to the public. *Id.* at 3.

Factually, then, Respondents contend that they submitted all required 48-hour reports. Any errors involving the filing of such reports for the dates in question are not their own.

Nonetheless, Respondents remain amenable to conciliation consistent with the Commission's own precedents. See MUR 4366;³ see also Respondents' Letters of January 9, 1998 and February 2, 1998.

The General Counsel's Brief also misses the mark on the law, particularly with respect to the allegations regarding two (2) of the thirty-four (34) contributions at issue. There is no dispute that the \$2,425.01 contribution from Team Victory '96, a joint fundraising committee, was reported correctly on the Zimmer for Senate Committee's October 18, 1996 48-hour report (the first day of 48-hour reports for the 1996 general election). While it was generally the policy of Respondents to include the name of the ultimate contributor, 11 C.F.R. § 104.5(f) requires only the inclusion of the "identification of the contributor." Without more specific direction in the regulation, Respondents met the technical requirement of the regulation by reporting the \$2,425.01 contribution from Team Victory '96, and no violation occurred in any instance. In order to provide the information sought on the Reports of Receipts and Disbursements, Respondents did include the \$1,000 from contribution from Jay Bernstein and Interstate Carriers on their post-election report.


III. CONCLUSION

For the foregoing reasons, Respondents respectfully request that the Commission reject the Office of General Counsel's recommendation regarding a finding of probable cause. In the

³ In MUR 4366 (regarding Democrat Phil Schiliro's congressional committee), the Commission entered into a conciliation agreement dated January 22, 1997, which concerned that campaign's failure to file 48-hour notices for some 18 contributions (not loans) totaling \$34,500. The campaign was assessed a \$2,000 penalty (a mere 5.8% of the total at issue). The reason proffered by that campaign (which is similar to the allegations in the present matter) was that the campaign failed to transmit the records to Clerk of the House (despite believing that they did so), due to "an error in technological transmission [i.e., a fax machine snafu] and not knowing and willful."

alternative, Respondents respectfully request that the Commission accept Respondents' previously submitted Conciliation Agreement.

GENERAL COUNSEL'S REPORT

I. BACKGROUND

On November 6, 1997, the Federal Election Commission ("Commission" or "FEC") found reason to believe that Zimmer for Senate, Inc., and David Millner, as treasurer (the "Committee" or "Respondents") violated 2 U.S.C. § 434(a)(6)(A). The reason to believe finding was based on the Committee's failure to file thirty-four 48 Hour Notifications for contributions totaling \$39,500 in connection with the 1996 campaign for the Senate in New Jersey. In order to expedite the resolution of the matter, the Commission also decided to enter into preprobable cause conciliation with Respondents.

Because Respondents apparently had changed their business address some time earlier without notifying the Commission of the change of address, they could not be notified of the reason to believe finding until December 11, 1997. Respondents subsequently requested an extension to January 9, 1998, to prepare a response to the reason to believe finding.

On March 12, 1998, the Commission rejected Respondents' counteroffer, and approved a conciliation counterproposal.

This Office sent a General Counsel's Brief ("GC Brief") to Respondents on April 23, 1998 that recommends the Commission find probable cause to believe Zimmer for Senate, Inc., and David Millner, as treasurer, violated 2 U.S.C. § 434(a)(6)(A). A Response Brief was received on June 1, 1998. Attachment 1.

II. ANALYSIS

This Office's analysis of this matter is contained in the General Counsel's Brief dated April 22, 1998 ("GC Brief"). The current analysis addresses only the two substantive arguments raised in the Response Brief: (1) Respondents apparently continue to maintain the position that their treasurer's "firm belief that all 48-hour reports were sent" should supersede evidence to the contrary, and (2) Respondents contend that their reporting of a "\$2,425.01 contribution from Team Victory '96, a joint fundraising committee . . . met the technical requirement of [11 C.F.R. § 104.5(f)]."

As this Office previously stated in the GC Brief, the fax machine at the Senate Secretary's Office confirmed that only one page of contributions was filed with respect to Respondents' October 22, 1996 48 Hour Report—as opposed to the five pages that Respondents apparently are insisting they filed. Also, the Commission's records do not indicate that any

October 23, 1996 48 Hour Report, purportedly filed by the Committee, was received from the Senate Secretary's Office; and Respondents have been unable to find a receipt verification for the report that they claim was filed on that date.² These facts are consistent with the conclusion that the Committee did not file the 48 Hour Reports at issue.

In addition, despite Respondents' characterization, the \$2,425.01 received by Zimmer for Senate from Team Victory '96, a joint fundraising committee, was a transfer, not a contribution. A committee receiving such a transfer must not only report the total amount transferred but must also itemize its share of gross proceeds as contributions from the original contributors. 11 C.F.R. § 102.17(c)(8)(i)(B). See also *Federal Election Commission Campaign Guide For Congressional Candidates and Committees* at page 20. Thus, Respondents' claim that they met a technical reporting requirement by reporting the \$2,425.01 as a contribution from Team Victory '96, without reporting original contributors, is plainly wrong. Accordingly, this Office recommends that the Commission find probable cause to believe that Zimmer for Senate, Inc., and David Millner, as treasurer, violated 2 U.S.C. § 434(a)(6)(A).

III. DISCUSSION OF PROBABLE CAUSE CONCILIATION



On June 29, 1998, the Federal Election Commission found that there is probable cause to believe that your clients, Zimmer for Senate, Inc., and David Millner as treasurer, violated 2 U.S.C. § 434 (a)(6)(A), a provision of the Federal Election Campaign Act of 1971, as amended, in connection with contributions they received during 1996.

The Commission has a duty to attempt to correct such violations for a period of at least 30 days and no more than 90 days by informal methods of conference, conciliation, and persuasion, and by entering into a conciliation agreement with a respondent. 



CONCILIATION AGREEMENT

This matter was initiated by the Federal Election Commission ("Commission"), pursuant to information ascertained in the normal course of carrying out its supervisory responsibilities.

The Commission found probable cause to believe that Zimmer for Senate, Inc., and David Millner, as treasurer ("Respondents"), violated 2 U.S.C. § 434(a)(6)(A).

NOW, THEREFORE, the Commission and the Respondents, having duly entered into conciliation pursuant to 2 U.S.C. § 437g(a)(4)(A)(i), do hereby agree as follows:

- I. The Commission has jurisdiction over the Respondents and the subject matter of this proceeding.
- II. Respondents have had a reasonable opportunity to demonstrate that no action should be taken in this matter.
- III. Respondents enter voluntarily into this agreement with the Commission.
- IV. The pertinent facts in this matter are as follows:

1. Zimmer for Senate, Inc., is a political committee within the meaning of 2 U.S.C. § 431(4), and is the authorized principal campaign committee for Dick Zimmer's 1996 campaign in New Jersey for the Senate.

2. David Millner is the treasurer of Zimmer for Senate, Inc.

3. The Federal Election Campaign Act of 1971, as amended ("the Act"), requires principal campaign committees of candidates for federal office to notify in writing either the Secretary of the Senate, or the Commission, as appropriate, and the Secretary of State of the appropriate state, of each contribution totaling \$1,000 or more, received by any authorized committee of the candidate after the 20th day but more than 48 hours before any election. 2 U.S.C. § 434(a)(6)(A). The Act further requires notification to be made within 48 hours after the receipt of the contribution and to include the name of the candidate and office sought, the date of the receipt, the amount of the contribution, and the identification of the contributor. Id. The notification of these contributions shall be in addition to all other reporting requirements. 2 U.S.C. § 434(a)(6)(B).

4. Among the contributions that Respondents received between October 17, 1996 and November 2, 1996, there were thirty-four (34) contributions of \$1,000 or more totaling \$39,500 for which the Commission has no evidence that complete 48 Hour Notices were received as required by the Act. Respondents contend that they did transmit the reports by facsimile, but concur that there is no evidence that the reports were received as required.

V. There is no evidence that the Respondents' report of campaign contributions of \$1,000 or more received after the 20th day, but more than 48 hours before the 1996 General Election in

New Jersey, within 48 hours of receipt of the contributions, was received as required by the Commission, a violation of 2 U.S.C. § 434(a)(6)(A).

VI. Respondents will pay a civil penalty to the Federal Election Commission in the amount of Four Thousand three hundred dollars (\$4,300), pursuant to 2 U.S.C. § 437g(a)(5)(A).

VII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.

VIII. This agreement shall become effective as of the date that all parties hereto have executed same and the Commission has approved the entire agreement.


IX. Respondents shall have no more than 30 days from the date this agreement becomes effective to comply with and implement the requirement contained in this agreement and to so notify the Commission.

X. This Conciliation Agreement constitutes the entire agreement between the parties on the matters raised herein, and no other statement, promise, or agreement, either written or oral, made by either party or by agents of either party, that is not contained in this written agreement shall be enforceable.




