The 21st Century Political Action Committee ("21st Century") objects this Interrogatory on the grounds that the term "relationship is vague and ambiguous." 21st Century denies that it has ever "financed, maintained or controlled" any of the County Democratic Parties listed, or the Texas Democratic Party. Similarly, 21st Century denies that it has ever been "financed, maintained or controlled" by any of the County Democratic Parties listed or the Texas Democratic Party. It is a matter of public record that 21st Century participated in a limited number of transfers with the Texas Democratic Party. The relationship between 21st Century and the other parties is their common commitment to the Democratic Party, its ideas, principles, and candidates.

3. *Provide the date, amount and purpose of each and every transfer (including all direct and in-kind contributions) between the 21st Century Political Action Committee and each of the committees listed in Question 2.*

The information sought by this Interrogatory is contained in reports filed with the Federal Election Commission, as well as in documents produced in response to

Question No. 4. Because the information sought is as equally available to the Commission as it is to 21st Century, no further response is necessary.

4. *Identify and produce copies of all documents, including deposit slips and negotiated checks (front and back if applicable), representing, reflecting, referring to or relating to each and every transfer (including all direct and in-kind contributions) between the 21st Century Political Action Committee and each of the committees listed in Question 2.*
