In response to your letter dated May 27, 1999 and our recent telephone call, we have compared the list of federal transfers provided by the Federal Election Commission with the records of the Texas Democratic Party ("TDP") and the county party committees. The results outlined below reflect the TDP's best efforts to respond to your chart. In some instances, the county parties may not agree with the TDP and vice versa.

The TDP believes there may be two instances of duplicate entries on your list:
