- III. BACKGROUND:

Transfers-in from the Non-Federal Account for Non-Allocable Activity

The Harris County Democratic Party ("the Committee") received a \$1,280.06 transfer-in on September 3, 1996 and a \$48,171.25 transfer-in on October 1, 1996 from its non-federal account for non-federal activities disclosed on Schedule B of the Amended 1996 October Quarterly and Amended 1996 12 Day Pre-General Reports, respectively. The transfers-in were reported on Schedule H3, supporting Line 18 of the Detailed Summary Page. The non-federal activities were originally disclosed on Schedules H2 and H4 and were described as a 100% non-federal direct candidate support mailout, and as a 100% non-federal exempt expense, respectively. Furthermore, the non-federal disbursements correspond exactly to the transfers-in by amount and date (Attachment 2).

On May 7, 1997, a Request for Additional Information ("RFAI") regarding the Amended 1996 October Quarterly Report was sent to the Committee which advised it that the \$1,280.06 transfer-in from the non-federal account for non-allocable activity was impermissible. The RFAI recommended that the full amount of the transfer be returned to the non-federal account (Attachment 3).

On May 7, 1997, an RFAI regarding the Amended 1996 12 Day Pre-General Report was sent to the Committee which advised it that there were transfers-in outside of the 70-day permissible time period. This RFAI was based on the \$48,171.25 transfer-in for the corresponding non-federal activity reported on Schedule B (Attachment 4).

On May 14, 1997, the analyst spoke with Jennie Duggan, the Finance Director of the Committee, about the transfers-in for non-allocable activity. The analyst stated that they should refund the money transferred-in for the non-allocable activity. He also mentioned that they may need to declare a debt to the non-federal account if they are unable to immediately transfer funds (Attachment 5).

On May 21, 1997, Jennie Duggan called to verify if they could transfer-in money from their non-federal account for allocation, then make transfers back to the non-federal account to pay off their debt. The analyst replied that they could (Attachment 5).

On May 29, 1997, Second Notices were sent to the Committee for the Amended October Quarterly and Amended 12 Day Pre-General Reports noting that the Commission received no written response from the Committee (Attachment 6).

On June 2, 1997, the Commission received a response from the Committee for the 1996 Amended October Quarterly and Amended 12 Day Pre-General Report RFAs which included a Scheduled D listing a debt of \$50,068.27 to HCDP STATE PAC for excess transfers. The Committee also provided a copy of a check from the Committee to the HCDP STATE PAC for \$7,252.03 dated May 28, 1997 for debt payment. Regarding the Amended October Quarterly Report, the Committee stated that, "The \$1,208.06 transfer from the non-federal account has been incorporated into our debt on Schedule D." Regarding the Amended 12 Day Pre-General Report, the Committee stated that, "The Party has incorporated all 100% non-federal transactions (which were subsequently re-reported on a Schedule B) onto the above-mentioned debt schedule." The Committee calculated the debt by using the 70-day permissible time period, not by linking specific transfers-in with specific non-allocable disbursements (Attachment 7).

On June 30, 1997, the analyst called and left a message for the treasurer of the Committee. When Jennie Duggan returned the call, the analyst asked if any more transfers had been made to pay off debt to the non-federal account. Ms.

Dugan replied that they had not made any more transfers, and were waiting until the end of the reporting period to make transfers; however, she stated that they would make another transfer the following day and send a copy of the transfer check, by overnight mail (Attachment 8).

On July 2, 1997, the Commission received a letter and a copy of a check for debt payment from the Committee to the HCDP STATE PAC dated July 1, 1997 for \$200.00. The letter stated that the Committee is short on federal funds and has been financially unable to make many transfers to pay off the debt for excessive transfers-in, but that the Committee will pay off the debt as soon as it is financially able (Attachment 9). The Committee's 1997 Mid-Year Report discloses an outstanding debt of \$42,816.24 still owed to HCDP STATE PAC (Attachment 10).

This letter is in regards to your inquiries dated May 7, 1997. The Commission's concerns have been addressed as follows:

October Quarterly Report (07/01/96-09/30/96):

- Calculations on the Detailed Summary Page have been corrected
- Two 100% non-federal transactions in the amounts of \$369.05 and \$839.69 have been re-reported on a schedule B. Admin/Voter Drive totals have been recalculated to reflect this and the Party has also corrected the Detailed Summary Page.
- The Party recognizes that re-reporting the non-federal transactions on a Schedule B will show us as being over our transfer limit. Therefore, we have included a debt schedule that incorporates these transactions. A more detailed explanation of how we derived our federal debt can be found in the latter portion of this response.
- The \$1,208.06 transfer from the non-federal account has been incorporated into our debt on Schedule D.

12-day Pre-General Report (10/01/96-10/16/96):

- "PBA-EXEMPT", "TVB-EXEMPT", and "JBA-EXEMPT" were so called because of their non-federal content, meaning that they should be "exempt" from the definition of a federal activity. We recognize that this has caused some confusion, and have re-named them "PBA", "TVB", and "JBA" on the enclosed report.
- The Party has incorporated all 100% non-federal transactions (which were subsequently re-reported on a Schedule B) onto the above-mentioned debt schedule.
- We have included addresses previously omitted on Schedule B.

30-day Post-General Report (10/17/96):

- Calculations on the Detailed Summary have been corrected

- Clarified descriptions have been given for all Schedule B disbursements. "Reimb. for expenses" refers to the Party's reimbursement of individuals who paid neighborhood block-walkers and printers to produce and distribute literature that has been classified as federal literature.
- The Party has incorporated all 100% non-federal transactions (which were subsequently re-reported on a Schedule B) onto the above-mentioned debt schedule.

Because our calendar year-to-date totals have changed, we have enclosed an amended copy of our year-end report (11/21-12/31).

Explanation-HCDP Federal PAC debt to non-federal account:

We have calculated our debt to the non-federal account to be \$50,068.27. **The debt does not equal the entire amount of non-federal transactions subsequently classified as federal because of excess transfer capability remaining from our joint federal/non-federal allocations.** We have enclosed a worksheet that shows exactly which payments are applied to each transfer. You will see that all of the payments are attached to transfers within the permitted 70-day range. On the worksheets, "sum" refers to the total amount of non-federal transactions applied to the corresponding transfer.

The Party has already made one deposit to our non-federal account in the amount of \$7,252.03. This is the amount that the party was entitled to transfer to cover payments made in the last 60 days. Because of the portion of individual contributions received by the party, we often cover disbursements with more federal money than is required by the FEC. This deposit lowers our current debt to \$42,816.24. The \$7,252.03 deposit, along with any subsequent deposits made on or before June 30, 1997, will be reflected on our July Quarterly report.

We hope that the Party has sufficiently addressed all of the Commission's concerns. If this is not the case, or if you have any further concerns, please feel free to contact Jennie Duggan at (713)522-9361. Thank you very much.

This letter is in regards to our telephone conversation yesterday regarding the Harris County Democratic Party's debt from our Federal account to our Non-Federal account. I want to thank you for contacting me to let me know that you had referred our case to the General Counsel's Office.

Regarding the debt, the Party made a \$7,252.03 transfer immediately after setting up the debt. At the time, we had excess Federal money in our account and put all of these funds toward the debt. Since this time, however, we have been short on Federal funds. As our next FEC report will show, we have only \$474.94 in our Federal account, with several outstanding bills. As a result, we had not, until today, made another repayment transfer. On your advice, we have made a small transfer this afternoon to show that we still fully intend to pay off this debt as quickly as possible.

When we originally set up the debt, you instructed the Party to continue to operate normally, allocating operating expenditures as we always have. This is what we have been doing, and this is why we are paying off the debt more slowly than the FEC might prefer. However, as stated above, the Party has the best of intentions and will pay off this debt as soon as it is financially possible.


This letter is in regards to your inquiry regarding the activities PBA, JBA, and TVB. A more detailed description of their content is as follows:
