
Dear Ms. Smith:

Lorillard Tobacco Co. was notified on July 6, 1998, that the Federal Election Commission had received a complaint, which has been designated as Matter Under Review 4766. As the Commission will be advised by separate correspondence, Lorillard retained Bopp, Coleson & Bostrom on July 16, 1998, to represent it in this matter.

Pursuant to 2 U.S.C. § 437g(a)(1), Lorillard has the opportunity to demonstrate in writing within 15 days of notification why the Commission should take no further action. Our response would be due on July 21, 1998. We respectfully request an extension of 15 days to respond, which would be August 5, 1998.
