Philip Morris Incorporated was notified on July 7, 1998, that the Federal Election Commission had received a complaint, which has been designated as Matter Under Review 4766. As the Commission will be advised by separate correspondence, Philip Morris designated Bopp, Coleson & Bostrom on July 21, 1998, to represent it in this matter.

Pursuant to 2 U.S.C. § 437g(a)(1), Philip Morris has the opportunity to demonstrate in writing within 15 days of notification why the Commission should take no further action.
