Dear Sir or Madam:

On behalf of the Washington State Democratic Part, I request that you investigate United States Congressional candidate, Ron Taber, of the 9<sup>th</sup> District in Washington State for failure to file with the Federal Elections Commission.

It has come to my attention that Mr. Taber announced his candidacy and began his campaign spending without filing a report with the FEC. It is my understanding that a candidate is not required to file with the FEC unless he has raised or spent more than \$5,000. The following evidence suggests Mr. Taber has exceeded the \$5,000 limit:

- Distribution of printed materials including a tri-fold color brochure, a full-color business card and a flyer noting it was indeed paid for by Ron Taber for Congress (attachment a)
- Involvement in the Renton Riverdays Parade with a participation fee of \$50. His participation included a pick-up truck covered with yard signs
- Installation of email and website with the following addresses: [taberhq.tcmnet.com](mailto:taberhq.tcmnet.com) and <http://tcmnet.com/~taberhq/>
- Campaign appearances have been made across the state yet no travel expenses have been indicated
- Failed to report a minimum of \$1,367 in candidate filing fees required by the Washington State Secretary of State
- Reference by a reporter to a staff person, indication payroll expenses (attachment b)
- Reference to a campaign headquarters, the value of which should be disclosed even if location is personal home (attachment c)

With this evidence, it seems probable that at least \$5,000 has been raised and/of spent by the Ron Taber for Congress campaign. I am confident that, after further investigation, you will discover a violation of the Federal Elections Commission laws has occurred. I

would appreciate prompt attention to this matter as it is critical to the political process that voters know where a candidate raises and spends his or her money. Thank you for your consideration of this request.



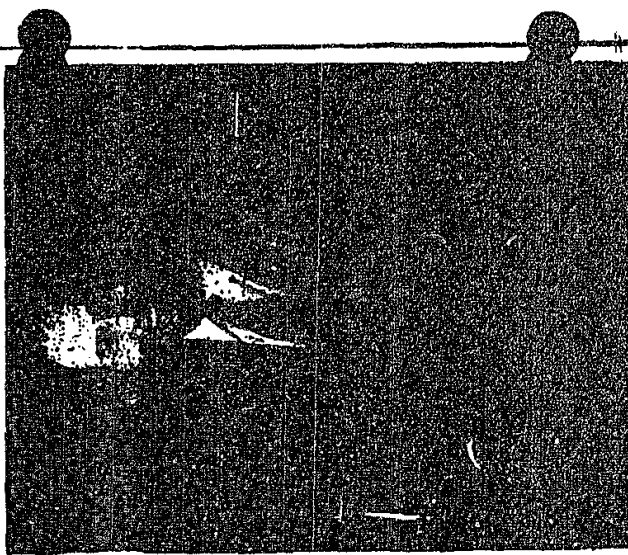

**R**epublicans all over America question why Bill Clinton, the poster boy for character flaws, gets away with it. They cite a laundry list of things he's done, most of them factual, and marvel at the lack of outrage.

Yet when it comes to a local candidate whose history makes his character an issue, many Republican officials are struggling off a very public record of questionable judgment. That candidate is Ron Taber, who is running for the Republican nomination in the Ninth Congressional District. The answer to the ignorance is bliss position on the part of GOP leaders appears simple: money. Taber has significant personal wealth, and his personal expenditures in the race against incumbent

Some have suggested Taber is pulling a fast one by running in the Ninth when his long term residence has been the Third. That's unfair. Taber literally lives on the line between the two districts. As former Thurston County Republican Party Treasurer Ron Sharp says, "Taber lives in the Third, but his cows live in the Ninth." His cattle ranch lies in both districts. Taber has said he will obtain a residence in the Ninth.

Democrat Mike Kreidler moved from the Third to the Ninth when he ran for the seat and won it in 1992, so the Democrats can hardly raise the residence issue.

The questions surrounding Taber need not focus on ideology. The Ninth elected another Christian conservative, Randy Tate, to Congress in 1994 and turned him out of office by a narrow margin in 1996.

Tate was succeeded by Democrat Adam

Smith, who must defend the seat against the Republican who wins the September primary.

## Sitting This One Out

Some of the more attractive candidates the Republicans might have offered to voters in the Ninth Congressional District decided to sit out the race.

Bob Seiple, who recently left Federal Way based World Vision after an extremely successful tenure as President, was the Republican's dream candidate. At World Vision, he had used enterprise solutions as a means of rebuilding communities broken by poverty, famine and disease. A deeply committed Christian with an outstanding personal reputation, excellent academic credentials and a grasp of global issues, he seemed an ideal choice for the party. A confidante of Seiple's told *The Reporter* that Seiple felt Congress would be too limiting and that he was seeking a job with a global reach. He got it last week when Secretary of State Madeleine Albright created a special Deputy Secretary of State role which was tightly tailored to Seiple's skills.

Former Federal Way Mayor Skip Priest, who had served as a senior aide to Republican legislators in Washington, D.C. early in his career, decided to run for the Legislature instead. Priest and his wife, Trish, known for her school age children and their needs weighed against the race. The same was true for another prospect, Federal Way City Councilman Phil Watkins and his wife, Nan.

## The Role Of Money

"So long as there are individuals who espouse extreme positions and have funds available to support them, they will drive highly qualified individuals off the stage. Long term, it will lessen the ability of citizens to derive benefits from highly skilled people," according to Doug Sutherland, Pierce County Executive and former Chairman of Mainstream Republicans of Washington.

Sutherland joins national observers in his concern about the trend toward well financed individuals with no government experience leaping into high level races without paying dues in the low to mid-level offices which serve as a training ground for public office. Ross Perot and Steve Forbes, men of great wealth, both view the Presidency as an entry level position. Perot's message of limited government drew voters from Republican nominees in 1992 and 1996, while Forbes' attack ads against Republican front runner Bob Dole wounded him early in the 1996 campaign.

California's recent experience may be instructive. In the 1990 June primary, two wealthy amateurs

sought the Democratic nomination for Governor. Democrats ignored both of them and chose Lt. Governor Grey Davis as their nominee.

No strong, experienced contender has emerged as an alternative to Taber in the Republican race in the Ninth Congressional District.

Democrat Adam Smith will tie up labor union funds, Democratic Party funds, and volunteer resources which could otherwise be diverted to other contests in King, Pierce and Thurston County. With a narrow 12 vote majority in the United States House of Representatives, the Republicans need every tactical advantage they can muster. And so some Republican leaders look the other way.

Taber has a questionable history which includes repeated fines and lawsuits involving his operation of federally subsidized apartments, being thrown out of the American Angus Association and barred from many county fairs for painting cattle black to pass them off as purebred Angus, and loose lipped remarks that many characterize as race-baiting.

Ironically, Republicans may be counting on Taber's money in vain. Some close observers of Taber's career suspect that while

he does have wealth, he may be "real estate poor." His resources are clearly locked up in land, buildings, and maintenance. The real question is, does he have the liquid capital to invest in the race in the manner the party expects? While Taber poured significant personal funds into his own candidacy for Superintendent of Public Instruction and Initiative 173, his school choice proposal, his actual contributions were not as large as he said they would be.

## The Ninth Congressional District

The Ninth Congressional District is a "swing district," one which can be won by either party. The party that holds the seat must expect to defend it. It covers parts of Pierce, King, and Thurston County.

## The Eikenberry Experience

Ken Eikenberry, a former FBI agent, legislator and three term Attorney General of Washington, is regarded as a straight arrow. He took the helm of the post-Watergate State Republican Party in 1976. Along with Executive Director, Tom Gildemeister, he rebuilt the party. The Republicans made gains in 1978 legislative races and won huge victories statewide in the Reagan landslide of 1980. Eikenberry, by then the Republican nominee for Attorney General, won the office in 1980, and was twice reelected. While not gifted in the courtroom as his predecessor, Slade Gorton, the AG's office was run quietly and well during his three terms.

After an unsuccessful run for governor in 1992, Eikenberry again sought to chair the Republican Party, and won the post in January of 1993. When he ran for reelection, Taber challenged him.

Taber ran against Eikenberry for state Chairman in late 1994 for the January 1995 election. In a contest that was noticeably bitter.

gry rumors about Eikenberry were outed. There was a backlash against Taber as a result, especially in Thurston County, where both can make their homes and are well known to the community. Taber eventually dropped out of the race.

Of the tone of the race, Eikenberry said: "In Ron Taber's campaign against me for state

Chairman, I was treated in ways that had never happened to me at the hands of a Democratic opponent."

## Landlord

Though Taber paints himself as an anti-government rebel, Ron Taber's personal fortune derives from the use of a government subsidy to finance the acquisition of apartment complexes in many parts of Washington state.

Taber used \$4 million in low cost, 50-year loans from the U.S. Department of Agriculture's Rural Economic Development program to build apartments in Thurston, Mason, Grant and Douglas counties. During Taber's race for Superintendent of Public Instruction, *The Seattle Times*, in an extensive investigation of Taber's activities as a landlord, published a copyrighted article which documented problems in Taber-owned buildings. Numerous landlord-tenant disputes came to light, including failure to control insects, attend to routine building maintenance, and provide good building management. At one point the USDA's Rural Economic Development office gave Taber's operations an unsatisfactory rating, the lowest rating possible. Taber's supporters told *The Reporter* that despite past problems, Taber had recently been extended in the program for an additional 20 years. We requested but have not received the written confirmation of this information from Taber, although we did receive an unsolicited copy of a positive energy audit from Taber's lawyer, Steve Hosch.

Taber was the object of a class action lawsuit in 1985 which charged him with failing to correct electrical, structural and plumbing defects in his apartment buildings. Part of the settlement of the suit was that Taber remove himself from hands-on operation of the apartments in question.

In 1996, the Thurston County Department of Environmental Health fined Taber for long term failure to maintain the septic system at an apartment building he owns south of Tumwater.

## Painted Cow Get Taber Banned By Angus Association

Taber raises beef cattle, and has even managed to make showing cattle at county fairs controversial. In 1984, the American Angus Cattle Association disciplined Taber for literally painting crossbred cattle which were only part Black Angus to make them appear purebred. He was also cited for forcing extra water down the animals' throats just before showing them so that they would meet weight requirements. The Association eventually ousted Taber and barred him from their shows. Taber filed a lawsuit against the association which he dropped part way through the trial as the facts

worked against him. He has been barred from exhibiting in the Clark, Lewis, and Thurston County Fairs.


## The Merry Prankster

An uncontested fact about Ron Taber is that he was the head of the radical Students for a Democratic Society while at Washington State University. The 1998 Taber, a born again, conservative Christian, has left that world behind.

Like a little boy with a live frog, Taber has an interesting habit of thrusting a dried bull penis, used as the tip of a cane, toward visitors to his ranch who intended to shake his hand—not the male member of a cow. Such an amazing number of Republicans who had visited the ranch related this experience that *The Reporter* felt compelled to include it in this story.

Taber is best known in some quarters for a remark during his 1996 campaign for Superintendent of Public Instruction, when he said that "Spanish is the language of doormen, dishwashers, and fruit pickers." It is surprising that someone who spends so much time tilting at windmills does not seem to know that it is also the language of *Don Quixote* author Miguel Cervantes, not to mention Octavio Paz and Carlos Fuentes. But Ron Taber's Ph.D. from Washington State University was in American Studies.

The legitimate point, used with great success in California's recent passage of an initiative requiring English immersion training instead of long term bilingual education, is that command of the English language is the basis for success in America. The challenge Ron Taber will pose for the Republicans throughout the campaign is that he likes to use outrageous examples to make a point. Some apologists for Taber say that Reagan did the same thing, but Reagan had a great ability to connect with a broad range of people, a sense of good will toward others, and immense personal charm.

Though the decision to write this article was sparked by the offer of an interview with Ron Taber by one of his campaign workers, he did not make himself available, nor provide formal position statements despite direct requests from the *Tacoma Reporter*.
