Dear Mr. Turley:

As of August 14, 1998, I have not raised or spent \$5,000 in my campaign for Congress to represent the Ninth District of Washington.

Attached are two articles from major dailies that covered the politically motivated complaint that I had spent more than \$5,000 containing my response indicating that I had not spent or raised enough money to have to make an FEC filing.

I am familiar with the rules of the FEC, having requested an FEC candidate packet in 1997, I believe, and having had contact with the NRCC regarding the rules for candidates. In addition, I ran for state office in 1996 and completed all my filings with the Public Disclosure Commission in Olympia.

During the month of August, I exceeded the amount of \$5,000, triggering the requirement to file with the FEC. That filing (the 12 day filing) has a cut off of August 26, 1998. Therefore you will have this filing in a few days. It was August 16, that I exceeded the \$5,000 expenditure and became liable to report all the funds expended to date in the campaign and the expenditures between that date and August 26, 1998.

Now, I respond to the specific allegations of the State Democrat Party in the order in which they are listed in Mr. Berendt's letter of August 2, 1998 and conveyed to me by letter dated August 14, 1998.

1. The brochure and cards cost \$2,029.55. A copy of the printer's invoices is attached.
2. I paid an entry fee of \$50.00 for Renton Riverdays Parade. The yard signs were from my 1996 campaign for Superintendent of Public Instruction. The truck was decorated for this and three other parades with balloons and streamers purchased at K Mart for \$34.00, an invoice for which is attached.
3. The email and website were installed for home use and a previous campaign. The costs of updating my website for the 1998 campaign was incurred after August 20, 1998.

4. I have made few campaign appearances and none across the State. This may be a reference to my presence at the State Republican Convention. I was a delegate to this convention and I did not address a session of the convention. I have fuel expenses for travel to the Pierce County Convention, King County Convention and several other events totaling \$44.48.
5. I paid a filing fee of \$1,367.00
6. I have no paid staff. I Reimbursed Karen Herd \$8.40 for her phone expense working at home. I have and in-kind contribution from a volunteer political consultant of \$475 at his regular hourly rate (a copy of which is attached).
7. My campaign headquarters is a bedroom at my personal residence. There has been no campaign until the week of August 17, 1998 and therefore no value is declared until then. I will report a half month in-kind contribution from myself in the 12 day report.

In addition to these expenditures listed by the Democrats I have spent and include invoices on:

1. A Newspaper ad (\$120.00)
2. Name Tags from Tags trophies (\$23.49)
3. Vinyl truck sign (\$35 twice, total \$70.00)
4. Press Clipping Service (\$324)
5. A "Flag" table cloth used in campaign (\$22.09)
6. Paper and reproduction cost for 1000 sheets of miscellaneous campaign material reproduced on our home copy machine (\$30.00)
7. Bank charges for our Campaign checking account (\$40.00)

We have done no mailings as of this date and have no postage to declare.

We have no other costs of which we are aware.

The total costs as of our August 15 Cutoff date

On the income side we have attached a copy of the year to day contribution FEC form that will be submitted for our 12 day report. It clearly indicates that we have received less than \$5,000.

I hope this concludes this investigation.

Challenger Smith follows footprints of tennis shoes

The conventional wisdom is that there is little Sen. Patty Murray has in common with her leading would-be challenger, Rep. Linda Smith.

But in recent weeks, Republican Smith has stepped forward on several issues where Democrat Murray had been strong, perhaps in an effort to neutralize the topics as potential campaign issues.

For example, Wednesday, Smith signed on as co-sponsor of a measure that would require schools and libraries to install filters on computers to block children from seeing pornographic Web sites. The measure strongly resembles one that Murray co-sponsored in February and that was approved by the Senate.

Smith also has emerged as a supporter of Sound Transit, the voter-approved rail, bus and car-pool lane project for King, Pierce and Snohomish counties that has been a priority for Murray and all other members of the central Puget Sound-area congressional delegation. An ally of Smith on human rights issues, Rep. Frank Wolf, R-Va., is chairman of the House transportation appropriations subcommittee.

In response to a letter from Smith, Wolf agreed to send a top staffer to look over Sound Transit later this month. "You can count on me," Wolf wrote to Smith.

"I am impressed by the local commitment to this project and by the project's mix of local and regional transit options."

Murray spokesman Rex Carney said, "It's great to see Congresswoman Smith is beginning to focus on areas where Senator Murray is a recognized leader."

Smith spokesman Erik Loknessmo said the notion that Smith is aping Murray is "ridiculous."

"Linda Smith sets the pace in Congress, and Patty Murray is still tying her tennis shoes," he said. "The idea that Linda the populist would try to adopt liberal Patty Murray's record is ridiculous. She wants to stay as far away from liberal Patty Murray's record as possible."

Taber keeping low profile, for now

Two years after drawing attention by making controversial comments about Hispanics and self-financing in an unsuccessful bid for superintendent of public instruction, Ron Taber is trying a new tactic in his effort to unseat freshman Rep. Adam Smith.

"I'm not giving colorful interviews to reporters, and I'm not throwing my money around," he said. "I'm trying to present a new Ron Taber, one that's more circumspect and simply says I can do better for you."

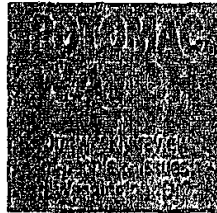
Taber has been so invisible that the state Democratic Party filed a complaint against him last week, accusing him of violating the law by failing to file spending reports with the Federal Election Commission. But Taber said he has not even spent the \$5,000 that would require him to fill out the forms.

Taber's strategy, he said, is to lie low through the three-way GOP primary, which he hopes to win based on name recognition. Then, he says, he will spend up to \$200,000 of his own money, combined with what he hopes will be a similar amount from his supporters.

That \$400,000 would be less than the \$450,000 already raised by the indefatigable Smith, who plans to spend the rest of the month campaigning in the district, from south Seattle to north Thurston County.

"I like my chances, but I've also learned in life you've got to work hard," Smith said. "It's up to me to tell folks who I am and what I've done, and if I do that, it won't really matter what my opponent does."

Pierce County auditor sued again over voter pamphlet practices

State House candidate John Prukop has sued the Pierce County auditor because she won't print his candidate statement in the local voters pamphlet.

Auditor Cathy Pearsall-Stipek plans to publish the pamphlet before the Sept. 15 primary. Candidates who want to submit statements and pictures for publication were given a form to follow.

Pearsall-Stipek said Prukop refused to follow the instructions, which, she said, are based on state law.

But Prukop claims Pearsall-Stipek is violating his state and federal constitutional rights to free speech. A hearing in Pierce County Superior Court is set for Tuesday.

"The state accepts my format," said Prukop, who is running as a Democrat for House

Position 1 in the 25th Legislative District. "She rejects it."

He said he submitted a 100-word statement of candidacy to the Secretary of State's office for the statewide voters'

ers' pamphlet, and it was accepted. He submitted a similar, 200-word statement to the auditor, because the county rules allow a longer statement. He submitted it Monday, but it was rejected, he said.

The auditor's office said he didn't follow the "mandatory standardized statement form," which requires candidates to respond only to the following topics: the candidate's education, occupation, professional qualifications, personal information, community involvement and personal views.

Prukop sued Wednesday in an attempt to stop the auditor from printing thousands of local pamphlets with a "none" as his response under each of the six topics. Such entries by the auditor will mislead voters, he said.

Pearsall-Stipek said Prukop is just trying to get publicity and said the lawsuit will cost taxpayers money because she must go to court to contest it. She said Prukop's picture will appear in the local voters' pamphlet and so will his statement, "except where he won't follow regulations,"

has observed during the past decade that government has degenerated from "protector of citizens' rights into an alarming police state, gradually eliminating your rights."

He wants a judge to rule that the auditor's standardized form is illegal and to order Pearsall-Stipek to accept his candidate's statement and pay his legal costs.

Prukop, a former radio broadcaster, is executive director of Citizens for a Constitutional Washington, "a citizen activist group based in Puyallup," he said in his statement.

He is running against Richard Hildreth for the Democratic nomination to take on incumbent Rep. Joyce McDonald (R-Puyallup).

Last year, five candidates sued Pearsall-Stipek in federal court after she decided to exclude their statements from the primary voters' pamphlet, saying the statements weren't about the candidates, as required in state law.

Pearsall-Stipek then agreed to print the statements - with a disclaimer saying they were the subjects of a lawsuit. The American Civil Liberties Union joined the lawsuit, saying it wanted to determine if the voters' pamphlets were constitutionally protected free speech.

A federal judge said that while some of the auditor's rules for candidate statements were too vague and ordered them rewritten, he ruled that it was legal for Pearsall-Stipek to exclude the statements if they weren't about the candidates.

State Democrats suspect that a Republican challenger to their man in the 9th Congressional District has spent more than \$5,000 on his campaign but hasn't reported it to the Federal Election Commission.

state Democratic Party, has filed a complaint, asking the FEC to look into the finances of Ron Taber, an Olympia-area businessman.

Taber, who is challenging incumbent Democrat Rep. Adam Smith (D-Kent), said he's innocent.

"I haven't raised \$5,000 yet, and I haven't spent \$5,000 yet," Taber said. "I'm keeping my powder dry. When I need to file a report to the FEC, I will."

Federal election laws require candidates to file financial reports if they spend more than \$5,000. Berendt, in his letter to the FEC, noted that Taber's candidate filing fee alone was \$1,367, and he also has sent out brochures.

Taber said the brochures cost him about \$450. "I am in full compliance."

Taber is one of three Republicans who are running against Smith, a first-term Democrat.

Public employees union voices opposition to Referendum 49

Another state employee labor group has come out opposed to Referendum 49, which would cut license-tab renewals and shift more state money into transportation.

The Washington Public Employees Association, which represents about 5,000 state workers, said the Republican-sponsored measure is a political quick fix.

"It doesn't fund major public transportation needs. It doesn't give car owners a real break. And it doesn't address other budget needs that will be shorted by revenues the state will lose in the future," said Gene St. John, the association's executive director.

The Washington Construction Industry Council, on the other hand, has endorsed the measure, saying it will provide much relief to traffic congestion.

"It provides funding for necessary improvements to our road and highway systems, which are an integral part of our state's economic development," said council vice president Brian Minnich, who also is director of legislative affairs for the Building Industry Association of Washington. That group also has endorsed Referendum 49.

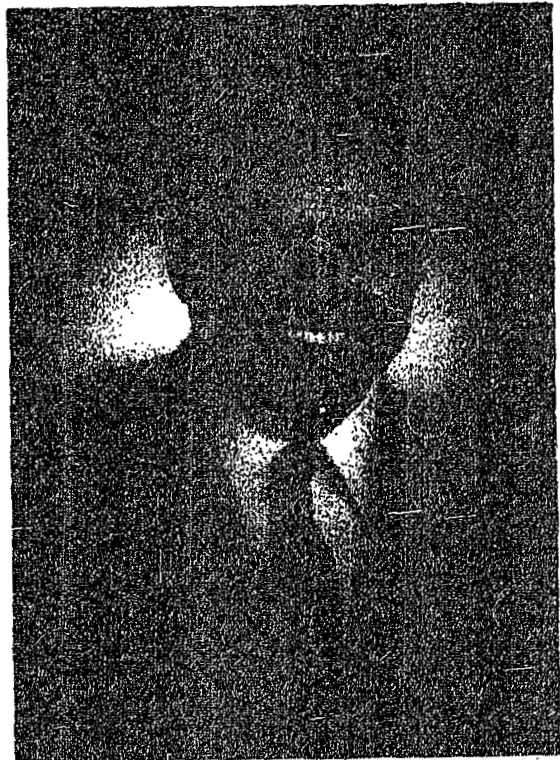
