18 ORDER AND JUDGMENT

19 This action for declaratory, injunctive and other appropriate relief was instituted by
20 the plaintiff Federal Election Commission ("Commission") against defendants California
21 Democratic Party ("CDP"), Democratic State Central Committee of California-Federal,
22 Democratic State Central Committee of California-Non-Federal, and Katherine Moret, as
23 treasurer, pursuant to the express authority granted the Commission by sections 307(a)(6) and
24 309(a)(6)(A) of the Federal Election Campaign Act of 1971, as amended ("Act"), codified at
25 2 U.S.C. 437d(a)(6) and 437g(a)(6)(A). The plaintiff Commission has satisfied all
26 jurisdictional requirements that are prerequisites to the initiation of this suit.

1 This Court has denied defendants' Motions for Summary Judgment and has granted
2 the Commission's Motion for Partial Summary Judgment. See FEC v. California Democratic
3 Party, 2004 WL 865833 (E.D. Ca. 2004).

4 Defendants have waived any and all claims, whether for costs, attorney's fees or other
5 expenses, relating to or arising in any manner from this proceeding, that it may have under
6 the Equal Access to Justice Act, 5 U.S.C. 504. Defendants have also waived all rights of
7 appeal from this Order and Judgment.

9 The Commission and defendants have stipulated to the entry of this Court's judgment
10 and consent to the issuance of this Order and Judgment.

12 Therefore, it is ORDERED, ADJUDGED AND DECREED that:

- 13 A. Defendants California Democratic Party, Democratic State Central
14 Committee of California-Federal, Democratic State Central
15 Committee of California-Non-Federal, and Katherine Moret,
16 Treasurer, violated 2 U.S.C. 441b(a) and 11 C.F.R. 102.5 by using a
17 non-federal account containing corporate and labor union monies to
18 make disbursements for mailings and radio advertisements in
19 connection with the March 10, 1998 special general election; violated
20 2 U.S.C. 441d(a) by failing to include the required disclaimers in
21 communications that expressly advocated the election of a clearly
22 identified federal candidate; and violated 2 U.S.C. 434(b) by failing
23 to disclose that they made independent expenditures on behalf of Lois
24 Capps.


- B. Defendants California Democratic Party, Democratic State Central Committee of California-Federal, Democratic State Central Committee of California-Non-Federal, and Katherine Moret, Treasurer, are permanently enjoined from using a non-Federal account containing union or corporate funds in connection with any special federal election in violation of 2 U.S.C. 441b and 11 C.F.R. 102.5; from failing to include all disclaimers required by 2 U.S.C. 441d(a) in communications that expressly advocate the election or defeat of a clearly identified candidate in such elections; and from failing to report their independent expenditures in the financial disclosure reports required by 2 U.S.C. 434(b) in such elections;
- C. Within 30 days from the entry of this Order and Judgment, defendants shall pay a civil penalty of \$30,000 to the Federal Election Commission, for which they will be jointly and severally liable;
- D. Within 30 days from the entry of this Order and Judgment, defendants shall transfer from the Democratic State Central Committee of California-Federal to the Democratic State Central Committee of California-Non-Federal the sum of \$77,281.67;
- E. Each side shall bear its own costs and attorney's fees; and
- F. It is hereby ordered that this Court shall retain jurisdiction of this action, and of any ancillary or supplemental actions thereto, in order to, among other things, implement and carry out the terms of all orders, judgments, and decrees that may be entered herein, including

those that may be necessary to assure compliance with this Order and
Judgment.

The Clerk of the Court is directed to enter this Order and Judgment.


