

FOR PRODUCTION OF DOCUMENTS

I was not the treasurer of the Randolph County Republican Executive Committee during the time period in question not having been elected until April, 1998. The previous treasurer was Mr. David Hamilton, who passed away some weeks prior to my election as treasurer. My answers to these interrogatories are therefore based on my information and belief and on what I believe the records of the Executive Committee reflect, not on my person knowledge.

1. Disclosure reports indicate that during 1996 you contributed/transferred \$10,000.00 to the Sixth Congressional District Republican Party ("6th District"). With respect to such transfer/contribution:

a. State the date on which you contributed/transferred such funds;

ANSWER: I did not transfer the funds, but the records reflect a transfer of \$10,000.00 by check dated 10/15/96.

b. State whether the funds were transferred pursuant to any request made by the 6th District;

ANSWER: These funds were transferred on recommendation of Continental Communications, Inc., a political consulting firm with the approval of the 6th District treasurer to pay an invoice for radio ads produced and placed by Blackwelder Communications for State Representatives Joanne Sharpe and John Cocklereece, Republican candidates for the 89th N.C. State House District.

c. State the purpose of such transfer/contribution;

ANSWER: See answer to 1.b. above.

d. Identify all persons involved in giving and receiving such funds;

ANSWER: Mark Stevens of Continental Communications, Inc. recommended to the Randolph County Committee to make the contribution. Assistant Treasurer, Lee Gavin, signed the check and sent same to the 6th District Treasurer, Collette Hoover, who endorsed and deposited same. Ms. Hoover then wrote a check to Blackwelder Communications.

e. Identify and produce all documents related to the transfer, including but not limited to check, memos, correspondence, etc.

ANSWER: Check from Randolph County to 6th District Committee date 10/15/96, for \$10,000.00 (attached) - 6th District deposit slip to First National Bank incorrectly dated 8/17/96 for \$10,000.00 (attached) (receipt from FNB (attached) accurately reflects deposit date of 10/17/96 at 2:18 p.m.) - 6th District check No. 1048 to Blackwelder Communications dated 10/17/96 (attached).

2. Disclosure reports indicate that you contributed/transferred \$22,425 to the 6th District on October 22, 1996. With respect to such transfer/contribution:

a. State whether the funds were transferred pursuant to any request made by the 6th District;

ANSWER: I did not transfer these funds, but the records reflect two contributions by two checks dated 10/22/96, one for \$9,850.00 and the second for \$12,575.00.

b. State the purpose of such transfer/contribution;

ANSWER: Purpose was to allow the 6th District Committee to pay two invoices to Advantage Mailing L.L.C. for mailings done respectively for the Republican House

candidates in the N.C. State House District No.89, and the Republican State House candidates in State House District No. 25.

c. Identify all person involved in giving and receiving such funds.

ANSWER: Mark Stevens, Lee Gavin, Collette Hoover

d. Identify and produce all documents related to the transfer, including but not limited to check, memos, correspondence, etc.

ANSWER: Randolph Committee check no. 1039 for \$9,850.00 dated 10/22/96 (attached) - Randolph Committee check no. 1040 for \$12,575.00 dated 10/22/96 (attached) - 6th District First National Bank deposit slip for \$22,425.00 date 10/23/96 (attached) - 6th District First National Bank check nos. 1063 for \$12,556.00 and 1064 for \$9,820.00 to Advantage Mailing (attached).

3. Disclosure reports indicate that during 1996 you contributed/transferred \$13,925 to the Buncombe County Republican Party ("Buncombe County Committee"). With respect to such transfer/contribution:

a. State the date on which you contributed/transferred such funds;

ANSWER: I did not transfer those funds. The records reflect that those funds were transferred by check no. 1050 dated 10/23/96 for \$13,925.00.

b. State whether the funds were transferred pursuant to any request made by the Buncombe County Committee;

ANSWER: These funds were transferred pursuant to recommendation by Continental Communication, Inc. No request was made by the Buncombe County Committee.

c. State the purpose of such transfer/contribution;

ANSWER: The purpose was to pay Advantage Mailing for mail for Republican candidates for the North Carolina State House in State House District No. 51.

d. Identify all persons involved in giving and receiving such funds;

ANSWER: Mark Stevens of Continental Communications, Lee Gavin, Assistant Treasurer, Randolph County Committee. No direct communication between the Randolph Committee and the Buncombe Committee is reflected in the records.

e. Identify and produce all documents related to the transfer, including but not limited to check, memos, correspondence, etc.

ANSWER: Cancelled check no. 1050, dated 10/23/96, from the Randolph Committee to the Buncombe Committee (attached).

4. State whether you had any discussion with the 6th District or the Buncombe County Committee regarding the use of any of the funds referenced above in questions 1-3. If so:

a. State when you had such discussions;

ANSWER: None, however, Continental Communications, Inc. as political consultant coordinated specific recommendations for contributions by the Randolph Committee and specific recommendations for the expenditures.

b. State the substance of such discussions, and specifically whether you provided either of the recipient committees with any instructions, or made any request or suggestion, about the use of the fund, i.e., whether to use the funds on state or federal elections, on advertising, voter mailings, get-out-the-vote activity;

ANSWER: It was understood by all parties that any

contributions made by the Randolph Committee to Buncombe Committee were for the purpose of paying for expenditures on behalf of Republican candidates for the North Carolina House of Representatives only.

c. Identify all persons involved in such discussions;

ANSWER: Mark Stevens, Lee Gavin, Collette Hoover, Alan Pugh, Paul Shumaker

d. Identify and produce all documents related to such discussions, including but not limited to memos, correspondence, etc.

ANSWER: None.

5. Disclosure reports indicate that the 6th District made a \$10,000 payment/expenditure to Blackwater Communications on October 17, 1996. With respect to such payment/expenditure:

a. State whether you had any discussions with the 6th District about such payment/expenditure, and if so, state the substance of any such discussions;

ANSWER: None.

b. State whether you gave the 6th District any instructions, or made any request or suggestion, about the \$10,000 payment/expenditure, including but not limited to suggesting what vendor to use and the type of goods or services purchased, i.e., whether to use the funds on state or federal elections, on advertising, voter mailings, get-out-the-vote activity;

ANSWER: None, but Mark Stevens did. His instructions were that the contributions were to be used for the support of Republican candidates for the N.C. House of Representatives.

c. Identify any person from your committee involved in

reviewing, approving or making suggestions regarding the goods or services purchased;

ANSWER: Alan Pugh.

d. Identify and produce all documents related to the payment/expenditure, including but not limited to scripts, tapes, memos, notes, correspondence, information stored on or created by computer.

ANSWER: None.

6. Disclosure reports indicate that the 6th District made a \$22,376 payment/expenditure to Advantage Mailing on October 23, 1996. With respect to such payment/expenditure:

a. State whether you had any discussions with the 6th District regarding such payment/ expenditure and if so, state the substance of any such discussions;

b. State whether you provided the 6th District with any instructions, or made any request or suggestion, about the \$22,376 payment, including but not limited to suggesting what vendor to use and the type of goods or services purchased, i.e., whether to use the funds on state or federal elections, on advertising, voter mailings, get-out-the-vote activity.

c. Identify any persons from your committee involved in reviewing, approving or making suggestions regarding the goods or services purchased;

d. Identify and produce all documents related to the payment/expenditure, including but not limited to scripts, tapes, memos, notes, correspondence, information stored on or created by computer.






