As you know, my colleagues and I are counsel to Congressman John Tierney with respect to MUR 4803. We have just been retained to represent the other respondents, Michael Goldman d/b/a Goldman Associates and H & C Service Corp. d/b/a Hawthorne Hotel. Designation of Counsel forms for each of these respondents are attached hereto.


As I indicated to you in our telephone conversation yesterday, I believe that we will wish to pursue pre-probable cause conciliation on behalf of all of the respondents.
