On October 13, 1999, your client, Walt Roberts, was notified that the Federal Election Commission found reason to believe that he violated 2 U.S.C. §§ 441a(f), 441f and 441b(a), provisions of the Federal Election Campaign Act of 1971, as amended. Again, on April 25, 2000, the Federal Election Commission found reason to believe that your client violated 2 U.S.C. § 432(h), a provision of the Federal Election Campaign Act of 1971, as amended ("the Act").

Pursuant to an investigation of this matter, the Commission has issued the attached Subpoena which requires your client, Walt Roberts, to appear and give sworn testimony on December 11, 2000 at 3:00 p.m. which will assist the Commission in carrying out its statutory duty of supervising compliance with Act.




