Re: **Matter Under Review 4821 ("MUR 4821")**

Dear Mr. Turley:

I received on October 24th, 1998 your letter dated October 21, 1998 pertaining to MUR 4821. The complainant in MUR 4821 alleges that, in connection with the 1995-96 and 1997-98 election cycles, I contributed more than \$1,000 to Lazio For Congress, the authorized campaign committee of Representative Rick Lazio, in violation of the individual contribution limit set out in 11 C.F.R. § 110.1(b)(1). My contributions were in full compliance with this regulation, and I request that I be dismissed from MUR 4821 with no further action.

An individual may contribute up to \$1,000 to a candidate with respect to any election to federal office. 11 C.F.R. § 110.1(b)(1). This \$1,000 limit is applied separately with respect to a primary election and to the subsequent general election. 11 C.F.R. §§ 110.1(j)(1), 100.2(b),(c). As a result, an individual contributing the maximum amount to each of the two elections will contribute a total of \$2,000 to a campaign committee during an election cycle.

For your reference, I am enclosing excerpts from the Lazio For Congress Reports of Receipts and Disbursements that report my six (6) contributions during the 1995-96 and 1997-98 election cycles cited by the complainant. The excerpts were obtained from the Commission's internet web site and its public records office. I note for the Commission that the reference to "9/10/96" for my contributions on page 5 of the Individual Contributor Data print-out provided by complainant should be "9/11/96." The reports clearly state that, with respect to each of the two election cycles at issue, I contributed an aggregate of \$1,000 to Lazio For Congress with respect to the primary election, and an aggregate of \$1,000 with respect to the general election.


