

Dear Ms. Boyt:

I am in receipt of a letter from the Federal Election Commission that has included a complaint filed by Mr. Kenneth J. Herman against Rick Lazio. This complaint states that Congressman Lazio has received numerous contributions in excess of the \$1,000 per election limit and highlighted my contributions as having exceeded this limit.

As I understand the law, I am permitted to contribute \$1,000 to Congressman Lazio's primary election and \$1,000 to Congressman Lazio's General Election for a total of \$2,000. Thus, while the raw data submitted with the complaint shows that I contributed a total of \$1,500 to Congressman Lazio in 1997, the Lazio for Congress reports (attached) show that I contributed \$1,000 toward Congressman Lazio's 1998 primary election and \$500 toward Congressman Lazio's 1998 general election. I trust this clears up any confusion with respect to this matter.
