We are in receipt of the documentation related to MUR 4827 and on behalf of the National Republican Senatorial Committee, the Campbell Victory Fund and Stuart Roy (see attached Statements of Designation of Counsel), we respectfully request an extension of time in which to respond.

We received these documents on Monday, November 9<sup>th</sup>, 1998. Thus, our response is scheduled to be due on November 24<sup>th</sup>, 1998.
