Dear Sirs:

I am in receipt of your communication of October 30 accusing me of violating campaign finance laws.

As I understand it, I am accused of making a pre-primary contribution to Tom Udall's congressional campaign after the primary. I enclose copies of the cancelled checks covering all the contributions I made to Mr. Udall's campaign. As you will note, the first check is for \$500.00, dated May 4, 1998, about a month *before* the primary. The second check, in the amount of \$1000.00, is dated August 19, 1998 and was intended for Mr. Udall's general election campaign.

Both these contributions are entirely within the law. It is clear that the New Mexico Republicans have filed a bogus complaint against me, and, likely, against Mr. Udall's campaign. If this is the case, I hope they will be punished for wasting everyone's time.
