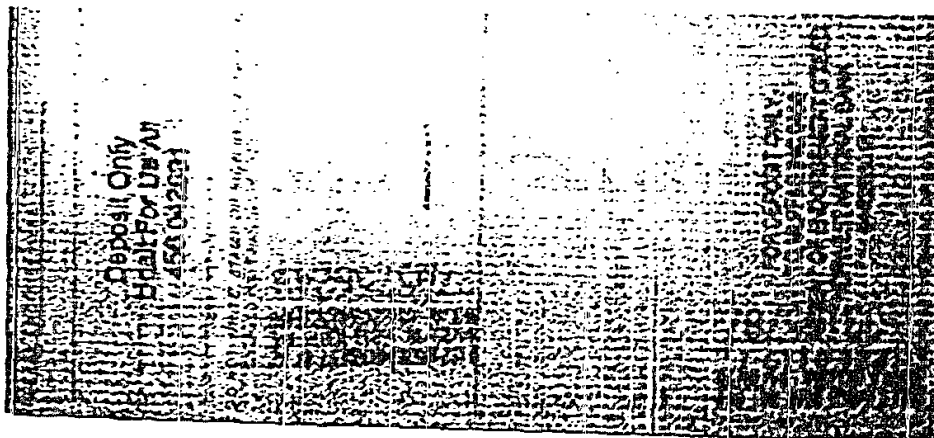
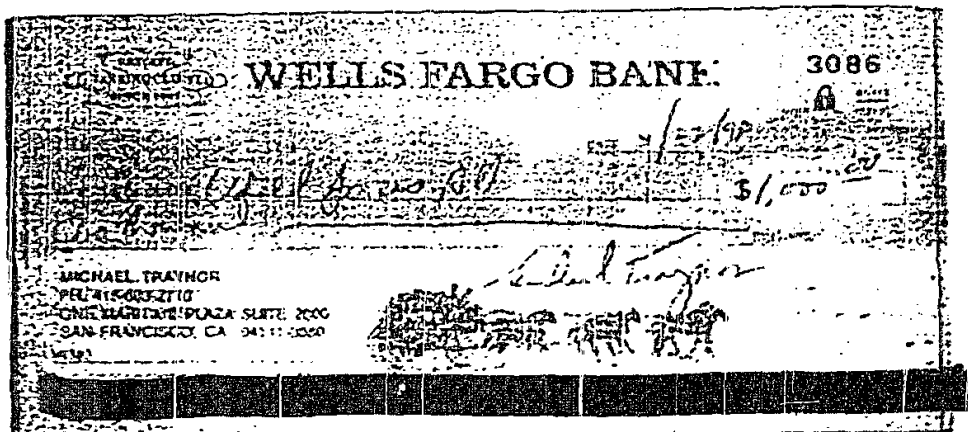
This letter supplements my letter to you dated November 5, 1998 regarding the above-captioned complaint against Michael Traynor. Enclosed please find: (1) a copy of a check (#3086), dated April 22, 1998, from Michael Traynor to Udall For Us All for the primary election campaign in the amount of \$1,000; (2) a redacted bank statement for the period April 16, 1998 through May 15, 1998 which shows that Mr. Traynor's contribution to Mr. Udall's primary election campaign of \$1,000 (check #3086) was paid on April 30, 1998, prior to the June primary; (3) a copy of a check (#3136), dated August 5, 1998, from Michael Traynor to Udall for Us All for the general election campaign in the amount of \$1,000; and (4) a redacted bank statement for the period July 16, 1998 through August 17, 1998 which shows that Mr. Traynor's contribution to Mr. Udall's general election campaign of \$1,000 (check #3136) was paid on August 13, 1998, after the primary election. As these documents demonstrate, Mr. Traynor's contributions were lawful and the Udall campaign correctly reported Mr. Traynor's contributions.

I trust that this information will enable you to close this matter for Mr. Traynor. If you need additional information, please let me know.

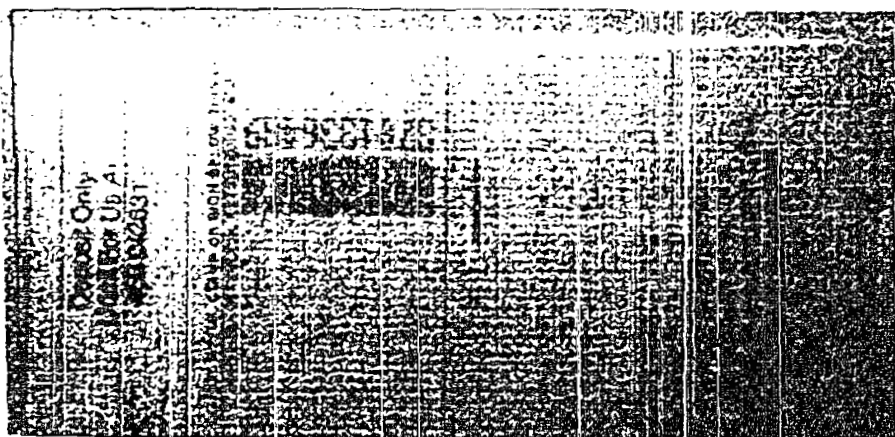
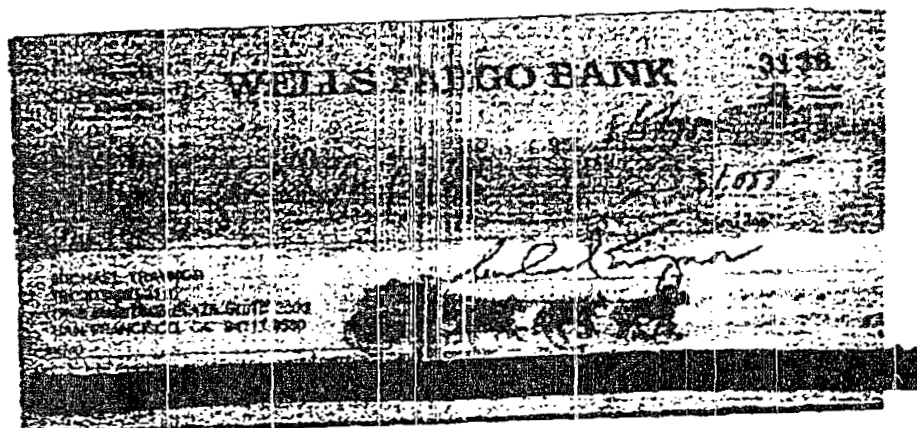
