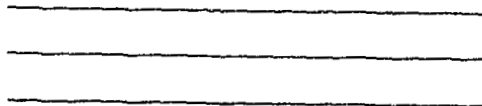

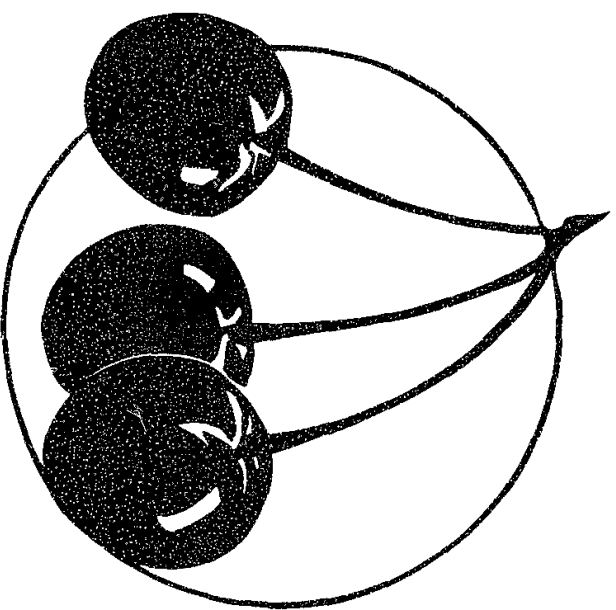

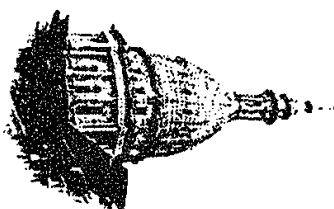
From the Desk of
