Dear Mr. Turley,

I received your letter, referenced MUR 4837, that outlines a complaint filed by Suzanne Stein, Treasurer and wife of Candidate Stein for Congress, regarding "Boyd for Congress" signs which were placed throughout the second Congressional District.

On Tuesday, I spoke with Jennifer Boyt and explained where the misunderstanding may have come from. Those signs were given "in-kind" by Robert Williams during the 1996 campaign. We had a number of signs left over after the election, so they were stored in a vacant shed to be used again in the 1998 election. The in-kind signs had a disclaimer which stated PPA Friends of Boyd for Congress. This was handled by the individual who in-kind the signs and if that was improper, it was done so unknowingly by Mr. Williams.

When Mrs. Stein called Congressman Boyd's district office under false pretenses to "help" the campaign, she was referred to Mr. Pete Windham, a local volunteer and supporter who was helping get these signs out. He has nothing to do with the signs other than his generosity in putting them out. This reference of Mr. Windham and his minimal role, serves to address the letter your office sent him on October 29, 1998.

I've taken the liberty of enclosing the page referencing the in-kind signs by Mr. Williams on 7/15/96. If you have additional questions, you may contact me at 202-546-4143 or 202-225-5235. I hope this clarifies the accusations made by Mrs. Stein.
