Any political advertisement, including those by Mr. Khoury, which was published in The Conservative Voice, was paid for by the candidate (invoice enclosed). Any advertisement The Conservative Voice placed in any other publication was paid for by The Conservative Voice, which in turn was paid by the ad's participants.

Neither the Conservative Voice nor Word Mill made campaign contributions to the Khoury campaign, in-kind, independent expenditure or otherwise.

There were no in-kind, nor independent expenditure, forms filed since there were no in-kind, nor independent expenditure, contributions made to any campaign.

The Inland Empire Conservative Coalition is no longer in existence and is not affiliated with The Conservative Voice.

Based on the above, I request that no action be taken against Shirlee Pigeon, Tom Pigeon, Conservative Voice, Word Mill Publishing (Word Mill P.R.) or Inland Empire Conservative Coalition.
