Thank you for your letter dated May 5, 1999, requesting a response within 15 days of receipt. Please allow me to present the facts in summary fashion to place the discussion in context.



LOSM, as a leader in the field of U.S. immigration law, contributes articles and bulletins to various organizations, magazines and internet websites across the U.S. and the world. LOSM sends out monthly bulletins to individual and institutions who specifically subscribe and request the bulletin.

Although we believe that there are foreign national recipients who request the Immigration Law Bulletin of LOSM, many recipients are U.S. citizens, for example, Human Resource Directors, Presidents and Vice Presidents of companies and other business owners. As mentioned above, LOSM also forwards this bulletin to several interested organizations for distribution among its members or readers, including the India Network Foundation ("INF"), a non profit organization established in 1996 as a 501 (c) (3) entity.

The Bulletin is not the work product of any 501 (c) (3) entity but is prepared and sent out by LOSM to all requesting individuals and entities. To the best of my knowledge, information and belief, INF has not solicited or collected any funds for the campaign contributions in question. To the extent that there may have been an inadvertent failure to edit out the paragraphs relating to fundraising, INF has already removed the article pertaining to the fundraiser and any references to the fundraiser from its website.
