Dear Ms. Davis,

By now, I would expect that the extra copy of our report has arrived at the FEC office and that you have received our faxed copy of the Post Office receipts showing the report mailed on Dec. 3, 1998 and received by the FEC on Dec. 6, 1998. (An extra copy of the postal receipts is attached to this letter.)

There was another question raised in the first material you sent to me, namely that the year-end 1998 report that we filed started with the December 4th date rather than an earlier correct date.

With this, we simply repeated a mistake we made on the missing 30-day post election report. We used a closing date of Dec. 3rd on that one, which was of course later than the correct date. With the two reports, we have fully disclosed the entire period.

Since we have fully disclosed and in fact did disclose a few days early on the late November-early December dates, I hope that this will not be a problem.

Here is what I think probably happened. I made the mistake and I know what the correct dates are. However, these reports were filled out during the holiday period and I was not concentrating at my best.

I'm sure I just got distracted and read the dates as "30 days from the election including filing for the period up to the 30th day"---- hence the December 3rd date.

We know Sue is safe with God in Heaven but the process we all had to work through as a family was not fun and I know I did not really concentrate on my work for many months.
