- III. BACKGROUND:

Failure to File Forty-Eight Hour Notifications

Ryan for Congress ("the Committee") has failed to file 48-Hour Notifications ("48-Hour Notices") for contributions totaling \$34,500 received prior to the 1998 General Election.

The candidate was involved in the 1998 Wisconsin General Election held on November 3, 1998. Prior Notice was sent to the Committee on September 30, 1998 (Attachment 2). The Notice includes a section entitled "48 Hour Notices on Contributions." This section reads: "Notices are required if the committee receives contributions (including in-kind gifts or advances of goods or services; loans from the candidate or other non-bank sources; and guarantees or endorsements of loans to the candidate or committee) of \$1000 or more, during the period October 15 through October 31. The notices must reach the appropriate federal and state filing offices within 48 hours of the committee's receipt of the contribution(s)."

On January 26, 1999, a Request for Additional Information ("RFAI") was sent to the Committee (Attachment 4). The RFAI notes on an informational basis that the Committee may have failed to file one or more of the required 48-Hour Notices for "last minute" contributions of \$1,000 or more. The notice requests the Committee to review their procedures for checking contributions received during the aforementioned time period. In addition, the notice states that although the Commission may take legal action, any response would be taken into consideration.

The Committee's February 5, 1999 response states that the 48-Hour Notice discrepancy occurred due to "problems with [their] reporting," specifically

If the campaign has an authorized committee(s), in addition to the principal campaign committee, the principal campaign committee must also file a consolidated report on Form 3Z and attach the report(s) of the authorized committee(s).

#### 48 HOUR NOTICES ON CONTRIBUTIONS

Notices are required if the committee receives contributions (including in-kind gifts or advances of goods or services; loans from the candidate or other non-bank sources; and guarantees or endorsements of loans to the candidate or committee) of \$1,000 or more, during the period October 15 through October 31.

The notices must reach the appropriate federal and state filing offices within 48 hours of the committee's receipt of the contribution(s). U.S. House candidates faxing 48-hour notices should transmit them to the FEC at 202/219-0174. Senate candidates should transmit them to the Secretary of the Senate at 202/224-1851. Note that 48-hour notices are the only FEC documents that may be faxed.

\*These dates indicate the beginning and the end of the reporting period. A reporting period always begins the day after the closing date of the last report filed. If the committee is new and has not previously filed a report, the first report must cover all activity that occurred before the committee registered.

\*\* Reports sent by registered or certified mail must be postmarked by the mailing date; otherwise, they must be received by the filing date.

**COMPLIANCE**

Treasurers of political committees are responsible for filing all reports on time. Failure to do so is subject to enforcement action. Committees filing illegible reports or using non-FEC forms (except for FEC approved computer generated forms) will be required to refile.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Commission Regulations define the term "purpose" to mean a brief statement or description of why a disbursement was made. Examples are "dinner expense", "media", "salary", "polling", "travel", "party fees", "phone banks", "travel expenses", "travel expense reimbursement" and "catering costs". Unacceptable descriptions include, but are not limited to "advance", "consulting", "contract labor", "election day expense", "expenses", "other expenses", "expense reimbursement", "miscellaneous", "outside services", "get-out-the-vote" and "voter registration". (11 CFR §104.3(b)(4)) Please amend Schedule B of your report to correct the descriptions which do not meet the requirements of the Regulations.

-Your report includes loans owed to Paul D. Ryan with due dates of 11/15/98. Please clarify the current status of these loans and disclose the current terms and conditions if the loans were renegotiated. Note that an overdue bank loan may be considered a prohibited contribution by the bank or lending institution. (11 CFR §100.7(b)(11))

-Schedule A of your report discloses a contribution(s) which appears to exceed the limits set forth in the Act (copies attached). You should

examine all of your contributions to check for additional excessives. The Committee's procedures for processing contributions should also be reviewed.

An individual or a political committee other than a qualified multicandidate committee may not make a contribution to a candidate for federal office in excess of \$1,000 per election. A qualified multicandidate committee and all affiliated committees may not make a contribution(s) to a candidate for federal office in excess of \$5,000 per election. The term "contribution" includes any gift, subscription, loan, advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for federal office. (2 U.S.C. §441a(a) and (f); 11 CFR §110.1(b), (e) and (k))

If the contribution(s) in question was not completely or correctly reported, you should amend your original report using the new or corrected information. If the contribution(s) exceeds the limits, you should either refund to the donor the amount in excess of \$1,000 or request a written redesignation and/or reattribution of the contribution(s) from the donor. All refunds, redesignations, and reattributions must be made within sixty days of receipt of the contribution. Copies of refund checks and copies of letters reattributing or redesignating the contributions in question may be used to respond to this letter. Refunds are reported on Line 20 of the Detailed Summary Page and on a supporting Schedule B of the report covering the period in which they are made. Redesignations and reattributions are reported as memo entries on Schedule A of the report covering the period in which the authorization for the redesignation and/or reattribution is received. (11 CFR §104.8(d)(2), (3) and (4))

The acceptance of excessive contributions is a serious problem. Again, the committee's procedures for processing contributions should be examined and corrected in order to avoid this problem. Although the Commission may take further legal action, prompt action by you to refund or seek redesignation and/or reattribution of the excessive amount will be considered.

D H. -Schedule A of your report indicates that your committee may have failed to file one or more of the required 48 hour notices regarding "last minute" contributions received by your committee after the close of books for the 12

Day Pre-General Report. A principal campaign committee must notify the Commission, in writing, within 48 hours of any contribution of \$1,000 or more received between two and twenty days before an election. These contributions are then reported on the next report required to be filed by the committee. To ensure that the Commission is notified of last minute contributions of \$1,000 or more to your campaign, it is recommended that you review your procedures for checking contributions received during the aforementioned time period. Although the Commission may take legal action, any response you wish to provide concerning this matter will be considered. (11 CFR §104.5(f))

-Your committee has previously indicated that it has been using "best efforts" to obtain the occupations and names of employers for contributors. This report discloses a significant increase in the number of entries for which the occupations and/or employers are not provided. Please note that the committee must make, in addition to the original solicitation, at least one additional written or oral request for the information within 30 days of the receipt of the contribution. A written request may not include an additional solicitation or material on any other subject, other than thanking the contributor for the contribution and must include a pre-addressed post card or envelope for the contributor's response. An oral request must be documented in writing. See 11 CFR §104.3(a)(4)(i) and 11 CFR §104.7

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. J. H. I am writing in response to your letter referenced, 30 Day Post General Report, and dated January 26, 1999, reference number C00330894. In your letter you raised five points which we needed to address.

1. We understand the need for specific expense coding, and future reports (June 30<sup>th</sup>) will reflect this. As to this report, we do use the term consulting for a few vendors. Below I have amended the description for these vendors:
  - Wilson Grand – media – 10-28
  - Wirthlin – polling 10-26
  - Keelan Communication – fundraising fee – 10-23
  - Murray – salary
  - Decision Makers – direct mail development – 10-21, 10-28
2. The loan from Paul D. Ryan is a personal loan from the candidate to his campaign. This loan was extended to June 30<sup>th</sup> 1999. \$10,000 was repaid in December. Unfortunately our end of year report did not reflect the extension. This will need to be amended also.
3. I have reviewed our financial database and donation records and would like to submit an amended report to reflect information which was reported incorrectly. This is also attached. Finally we have implemented another procedure which should allow us to identify any excess contributions before donations are deposited. This is now in place.
4. E. H. I have reviewed all of our 48 hour reports for the general election and have found the problem with our reporting. In total we reported 88 \$1000 or above donations made on October 15<sup>th</sup> through November 1<sup>st</sup>. These were faxed to the FEC. We subsequently reported during the same time 107 such donations in the Post General. The discrepancy occurred for deposits completed on 10/19/98. We had over 150 deposits on 9 different deposit sheets. When are Ass. Treasurer went to do the report she found only 2 deposit sheets. Our data entry person was using the 7 others to do donation entries. Since 2 deposit sheets were there she did not think that there were others out there. To avoid this in the future, all deposit slips which are used to generate the 48 report, will need to be "checked out" by the Ass. Treasurer.
5. With regards to the need to document the employer and occupation of those contributing in aggregate \$200 or more, we had been following the procedure of phoning the donor and requesting the information. However we had not been documenting these calls. Having read



your letter and requirements in a previous letter, we have now implemented the following which we hope will comply with the FEC requirements. This is below. Unfortunately this was not in place for this reporting period.

- We have pulled all those donors in the database that have contributed over \$200 but have no employer/occupation information and a letter requesting such information will be sent to these names.
- Starting from this date, a new procedure will be followed which should show the campaign doing its best effort at obtaining information promptly after receiving the donation. These procedures have been provided to the FEC in our last letter dated 1/19/99.

I would welcome any suggestions that you may have to our procedures. I am at your disposal, should you require any other information.
