Enclosed please find the executed Statement of Designation of Counsel from the Ryan for Congress Committee ("RFCC") authorizing me to act on behalf of RFCC. I reviewed the materials from Chairman Thompson in his letter dated August 11, 1999 and discussed the same with my client. My client desires to enter into a conciliation agreement with the FEC on mutually acceptable terms.


Briefly, my client fully acknowledges the vital importance of the 48 hour reporting requirements of 2 U.S.C. §§ 434(a)(6)(A)&(B) to the integrity of the Federal Election Campaign Act and the overall spirit of the federal campaign finance regulations. Both the paid RFCC staff and the many unpaid volunteers are instructed on the critical importance of full compliance with the FECA and additional FEC documentation. At the present time, the RFCC staff and Treasurer is diligently conducting and concluding their investigation of the circumstances surrounding the events between October 15 and October 31, 1998, in which the alleged violation of the 48 hour notice occurred. The results to date show potentially an isolated incident may have occurred involving an unintentional oversight resulting in faxing less than all of the required reports within the 48 hour deadline. Once the full details are of this potential incident are known I would like to discuss them with you with the hope of reaching a mutually acceptable conciliation.
