We interviewed the person who was responsible for sending the 48 hour notices of major contributions and she advised us that she had sent all the notices to the FEC as required.

Attached is our analysis of the notices sent where we have matched the contributions with the faxes indicated on the phone bill. In our view the analysis communicates a clear pattern of compliance which would indicate that we should not be subjected to a fine.


