Failure to File Forty-Eight Hour Notifications

The Heather Wilson for Congress Committee ("the Committee") has failed to file seventy-one (71) of the required Forty-Eight (48) Hour Notifications ("48-Hour Notices") totalling \$104,000 received prior to the 1998 Special General Election.

The candidate was involved in the Special General Election held on June 23, 1998. Prior Notice was sent to the Committee on May 18th, 1998 (Attachment 2). The Notice includes a section titled "48 Hour Notices on Contributions". This section reads "Notices are required if the committee receives contributions (including in-kind gifts or advances of goods or services; loans from the candidate or other non-bank sources; and guarantees or endorsements of bank loans to the candidate or committee) of \$1,000 or more, during the period:

06/4/98-06/20/98

The notices must reach the appropriate federal and state filing offices within 48 hours of the committee's receipt of the contribution(s).

On November 3, 1998, a Request for Additional Information ("RFAI") was sent to the Committee (Attachment 4). The RFAI notes on an informational basis that the Committee may have failed to file one or more of the required 48-Hour Notices for "last minute" contributions of \$1,000 or more. The notice requests the Committee to review their procedures for checking contributions received during the aforementioned time period. In addition, the notice states that although the Commission may take legal steps, any response would be taken into consideration.

On November 19, 1998 and March 22, 1999 amendments were received which addressed discrepancies between some 48-Hour Notices filed and failure to disclose some contributions on Schedule A, but did not address the issue regarding the failure to file 48-Hour Notices (Attachment 5).



- g. Our committee indicated a total of \$1000 in contributions from Mr. Daniel Growney on 6/11/98 and 6/16/98. These contributions are correct, but the previous contribution from Mr. Growney on 5/28/98 was mis-reported as a contribution for the special. It was in fact a contribution for the primary, but a clerical error was made when hand-writing the allocations on the report.
- h. Our committee indicated a contribution of \$5000 on 6/10/98 from Congressman John Boehner. - j. Our committee indicated a contribution of \$1000 from Keep Our Majority PAC on 5/8/98. This contribution was in fact to be allocated to the Primary election. Keep Our Majority PAC indicated their own clerical error, instructing our committee on the correct allocation. The correct allocation was \$1000 to our committee on 5/8/98 for the Primary, \$5000 on 6/5/98 for the special election.
