

DECLARATION OF STANLEY W. TUCKER

1. I am the President of MSBDFA Management Group, Inc. ("MMG"), a Maryland corporation which has initiated the above-referenced self-referral to the Federal Election Commission. I am submitting this Declaration to supplement the information provided to the Commission in the letter submitted to Lois Lerner, Esq. on April 7, 1999, by Joseph E. Sandler as counsel for the company.

2. Attached to this Declaration as Exhibit 1 is a chart indicating the sources of funds used by four officers of MMG to make certain contributions to candidates for federal office. Those officers included myself; Timothy L. Smoot, senior vice president for finance; Catherine D. Lockhart, executive vice president; and R. Randy Croxton, senior vice president, investments.

3. The information set forth on this chart is true and correct to the best of MMG's current information, knowledge and belief.

4. The chart reflects that I made a contribution in the amount of \$225 to the campaign of Rep. Elijah Cummings (D-Md.) on or about May 15, 1996 and that I made a

contribution in the amount of \$250 to the campaign of Rep. Albert Wynn (D-Md.) on or about June 25, 1997. These contributions were made with my personal funds and were not reimbursed by MMG or by any other person or entity.

I declare under penalty of perjury that the foregoing is true and correct to the best of my present knowledge, information and belief.


