Dear Mr. Velasquez:

I am writing as counsel for Mr. Angel Morey, Chief of Staff of the Governor of Puerto Rico, the Hon. Pedro Rosselló González. We have received and herein-below are responding to the complaint filed by Aníbal Acevedo Vilá, with the Federal Commission number MUR 4934.

The complaint has no allegations against Mr. Angel Morey and in any case the facts, as alleged in parts of the sworn statements attached to the complaint are ridiculous to say the least.

In the letter dated October 19th, 1999, you indicate that "the Federal Election Commission received a complaint with indicates that you may have violated the Federal Election Campaigns Act of 1971, as amended ("the Act...")." Again, nowhere in the complaint there is an allegation against Mr. Angel Morey and, in that case, he is definitely not a respondent. In addition, he is not even mentioned in the facts of the complaint.

Notwithstanding the above, we will make clear, in view of the fact that Mr. Morey is mentioned in parts of the sworn statements, that the allegations are not true and the alleged contribution was never made. See copy of Mr. Angel Morey's sworn statement.

In short, the allegation in parts of the sworn statement attached to the complaint by one Andrés Sánchez Delgado is that Mr. Morey acted as a messenger, as per instructions of an

assistant to the President of the Government Development Bank, Marcos Rodriguez Ema, and received a box which contained \$150,000.00 for the Governor's Campaigns Fund.

The allegation can in no way be interpreted as a violation of the Federal Election Campaigns Act of 1971. Governor Rosselló is a state elected official and not a federal elected official.

The position of the Governor of Puerto Rico does not fit under the definition of the term candidate as promulgated in the Federal Election Campaigns Act, 2 U.S.C.A. § 431(2). The term candidate is specifically defined as "an individual who seeks nomination for election or election to **Federal office**."

Furthermore, the term **Federal office** "means the office of President or Vice President, or of Senator or Representative in, or Delegate or Resident Commissioner to, the Congress." See 2 U.S.C.A. § 431(3).

Governor Pedro Rosselló was not running for any of these **Federal office** positions since the position of Governor of Puerto Rico is strictly local in nature and is no way related to the above referred positions.

The Act also defines the term contribution as "any gift, subscription, loan, advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for **Federal office**." See 2 U.S.C.A. § 431(8)(A)(i). If any contributions were made in the instant case, which we specifically denied, they were not made for the purpose of influencing any election for **Federal office** as required by the Act since, as we have repeatedly mentioned, Governor Pedro Rosselló was not running for **Federal office**.

Therefore, based in the above mentioned definitions, there is no doubt that the alleged illegal contributions made to the campaign of the Governor Pedro Rosselló are not covered by the provisions of the Federal Election Campaigns Act of 1971, since neither the position of Governor of Puerto Rico nor any contributions made to this campaign are covered by the Act.

Accordingly, legally the complaint and/or the facts are devoid of any merit. To support our position, we are including a sworn statement by Mr. Angel Morey, in which he indicates that the facts that are alleged are not true and that he has not received any such type of donation and, in addition, no donation at all for any political campaign.

We have also included sworn statements by past and present bodyguards and chauffeurs of Mr. Angel Morey, and full-time employees of the Restaurant in which the alleged incident occurred, all of which deny said type of allegation.

The facts and the exhibits reflect nothing else than a sexual harassment case alleged by Sánchez Delgado against Dr. Rodríguez Mateo, which an irresponsible politician like Mr. Aníbal Acevedo Vilá has used to file a complaint against the Hon. Carlos Romero Barceló, Resident Commissioner of Puerto Rico.

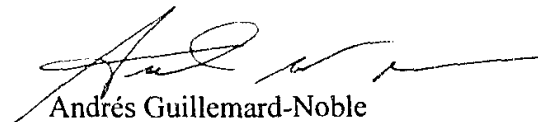
Once again, there has been no complaint filed against Mr. Angel Morey and in any case the facts are without merit and there is no need to enter in detail into the credibility of the allegations contained in the sworn statements accompanied in the complaint.

Accordingly, there is no possible violation of the Federal Election Campaigns Act of 1971 and, in addition, as explained above, there is no reason to believe otherwise. Therefore, the Commission should exercise its discretion and take no further action on this matter and so notify the undersigned.

9. That Mr. Andrés Sánchez Delgado lies maliciously while making the allegations against me.
