On March 6, 2001, the Commission found probable cause to believe that the Committee violated 2 U.S.C. § 441a and 11 C.F.R. § 110.1(b)(3)(i) for receiving funds in excess of net debt and then transferring those funds to the National Republican Senatorial Committee ("NRSC"). The Commission also approved a conciliation agreement

On May 11, 2001, the Committee submitted a counteroffer to the Commission's conciliation agreement. Attachment 1.
