The Commission also found reason to believe that Citizens for Mead and Thomas J. Riley, as treasurer; Citizens for Gardner and Randy Gardner, as treasurer; Leadership PAC 2002 and Pamela Sederholm, as treasurer; and Florida Republican Leadership PAC and Donna F. Winterson, as treasurer, each violated 2 U.S.C. § 441 f by permitting their names to be used to effect contributions in the name of another, but did not enter into pre-probable cause conciliation with these committees. The Commission took no action regarding Patrick Joseph Tiberi.
