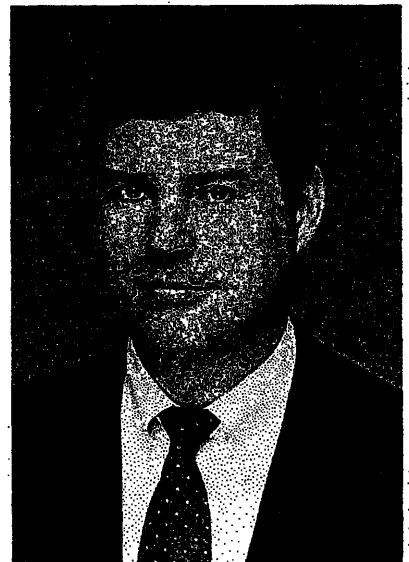

To my labor friends:
