Re: Complaint Against Toltz 2000, Karen Rokala as Treasurer

Dear Mr. Noble:

The National Republican Congressional Committee, by and through its General Counsel, hereby brings this complaint pursuant to 2 U.S.C. § 437g(a)(1) against Toltz 2000 and Karen Rokala as Treasurer. The National Republican Congressional Committee is located at 320 First Street, S.E., Washington, D.C. 20003.

**I. FACTUAL BACKGROUND**

Ken Toltz is a Democrat candidate for United States Congress from the sixth district of Colorado. His campaign committee is Toltz 2000, with Karen Rokala as its treasurer. On its 2000 April 15 Quarterly report, the Toltz campaign claimed to have received \$29,637.25 in contributions from other political committees, such as PACs. The accuracy of this and other aspects of the report are called into question because:

- Remarkably, the campaign failed to itemize virtually all of these PAC contributions.
- Specifically, the campaign only itemized one contribution, a \$137.25 in-kind from New Democratic Network.
- Other itemized in-kind contributions are suspect because of the amounts listed. For example, several are round numbers (*i.e.*, \$500, \$1,000), and several are for exactly \$1,000. One contribution was for \$1,119.25.

Such facts raise serious questions as to both the accuracy of Toltz's report, and the true source of his funding. A fundamental tenet of the Federal Election Campaign Act (the "Act") is public disclosure. Absent such public disclosure, the public's ability to cast an informed vote may be compromised, thus compromising our electoral process. Toltz's year-end report shows contempt for this process. As such, Commission action is warranted.

## **II. VIOLATIONS**

### **A. Toltz's Failure to Itemize \$29,500 of Alleged Contributions.**

Federal law mandates that all contributions which exceed \$200, or aggregate over \$200 when added to other receipts received from the same source during a calendar year, must be itemized. 11 C.F.R. § 104.3(a)(4). It is obvious that Toltz has failed to properly itemize numerous contributions, a clear violation of the Act and Commission regulations. Over 99.5% of all PAC contributions were not itemized.

Specifically, of the \$29,637.25 that was allegedly raised, \$29,500 was not itemized. See Attachment 1 (Toltz Report). The public has a right to know if these alleged contributions even exist, let alone whether such funds are illegal soft money. Such public deception requires immediate Commission action.

### **B. Toltz's Questionable In-Kind Contributions.**

Toltz's failure to itemize virtually all of his PAC contributions is troublesome enough. But his report reveals a second possible violation. Several of his in-kind contributions are round numbers, and several are supposedly for exactly \$1,000. These contributions, which suggest valuation by reverse-engineering, include:

- \$500 from Cindy Knox for "catering."
- \$500 from Rich Bradley for a "printer," and \$400 for "file cabinets."
- \$1,000 from Evan Dechtman for "web-site & database."
- \$300 from Richard Smith for "Refrig."
- \$500 from Lori Fox for "Lists & Data entry."
- \$1000 from Mollie Brundage for a "used laptop."
- \$1,000 from Robin Loup for "catering."

It is simply implausible that a used laptop just happens to be worth \$1,000. Likewise, it is equally unlikely that web-site and database services also happen to have been worth exactly \$1,000. The accuracy of all these valuations is highly dubious,

perhaps masking several excessive contributions. This becomes particularly apparent when they are compared to other in-kind contributions, which are valued to the penny. Accordingly, Commission action is warranted.

### C. Toltz's Excessive In-Kind Contribution.

Toltz's report lists an in-kind contribution from Joel Rosenstein in the amount of \$1,119.85. Of course, individuals are limited to giving \$1,000 per election per candidate. Thus, there appears to be an \$119.25 excessive contribution. Accordingly, Commission action is warranted.


### III. CONCLUSION AND PRAYER FOR RELIEF

Public disclosure is one of the central tenets of our campaign finance system, and flagrant violations such as those being perpetrated by Toltz must be stopped. For these reasons, and based upon the foregoing, the National Republican Congressional Committee respectfully requests that the Commission:

1. Take immediate action to require Toltz to disclose the true source of his funding;
2. Find that there exists a reason to believe that Federal law has been violated;
3. Promptly investigate the matter; and
4. Institute appropriate legal action to secure an appropriate fine for these violations.

The foregoing is correct and accurate to the best of my knowledge, information and belief.
