
This complaint asserts that Jon Porter and Friends of Jon Porter, Inc. violated the Federal Election Campaign Act (the "Act"), 2 U.S.C. §§ 431 et seq., and related regulations of the Federal Election Commission ("FEC" or the "Commission"), 11 C.F.R. §§ 100.1 et seq.

The facts clearly demonstrate that Porter violated one of the Act's most basic requirements. Under the Act, any communication that expressly advocates the election or defeat of a clearly identified candidate must bear a disclaimer giving the reader adequate notice of who paid for it. 11 C.F.R. § 110.11(a)(1)(1999). Specifically, it must "clearly state that the communication has been paid for by the [candidate's] authorized political committee." *Id.* § 110.11(a)(1)(i).

A flyer recently believed to have been distributed by Porter and his campaign contains a message from Porter to prospective voters in which "I ask for your support." It also asks the reader to "join our effort to elect Jon Porter for Congress." In fact, in large bold type, it states, "Jon Porter for Congress." However, nowhere does the flyer contain any language stating that it had been paid for by Porter's campaign committee. (Attachment A.)

There is no doubt that Porter's flyer expressly advocates his election. There is also no doubt that it contains no disclaimer as the law requires. There is every reason to believe that Porter will continue to commit such violations throughout the election cycle. Accordingly, the Commission should take swift action to remedy these violations, and seek an injunction so that they never recur.

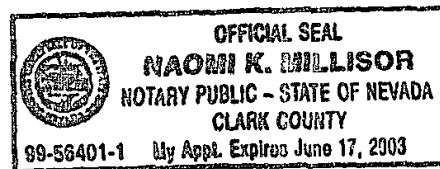

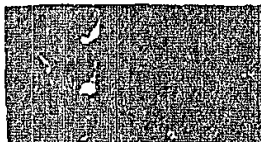
