Dear Ladies and Gentlemen:

This letter shall serve as a formal complaint against Gormley for Senate (NJ) Committee, Trump Hotels and Casino Resorts, Mirage Casinos and Harrah's Entertainment.

The Federal Election Law – 2USC-441a(a)(8) and the Federal Election Commission Regulations 110.6(b)(2) both provide that no individual may receive a contribution on behalf of a candidate for Federal office while acting as a representative of a corporation. Further, if such an individual receives a contribution, he must return it to the contributor. Finally, an individual who serves as a conduit of contributions to a candidate must report the original source and the intended recipient to the Commission and to the intended recipient.

The Gormley For Senate Committee, Trump Hotels and Casino Resorts and their executives Mr. Mark Brown, Mr. Lawrence Mullin and Mr. Fred Buro, Mirage Casinos and their executives Mr. "Skip" Bronson and Mr. Mark Juliano and Harrah's Casinos and their executives Mr. Howard Jonas and Mr. Herbert Wolfe are in violation of both the law and the regulation.

On March 27, 2000, according to the Press of Atlantic City, Trump Hotel Casinos and Resorts held a fundraiser to benefit William Gormley, a candidate for the U.S. Senate. Mr. Mark Brown, Mr. Lawrence Mullin and Mr. Fred Burro contacted various employees of Trump Hotels and Casino Resorts and solicited and received contributions from 33 employees (list attached) for a total of \$28,800.

Mr. Brown collected these checks. The checks then were turned over to Mr. Donald J. Trump who presented them to Mr. Gormley.

Similarly, Mr. "Skip" Bronson and Mr. Mark Juliano improperly solicited \$17,000 in contributions from Mirage casino employees (list attached) and other vendors with contracts with Mirage Casinos. Mr. Juliano collected these checks and sent them to Mr. Gormley.

Additionally, Mr. Howard Jonas and Mr. Herbert Wolfe solicited and received \$31,000 in contributions from employees of Harrah's casino "The Showboat" (list attached) and sent the contributions to Mr. Gormley.

In all cases, employees of these corporations were compelled by senior executives to give to Mr. Gormley's campaign in violation of the Federal Election Law prohibiting "bundling".


I urge a swift and thorough investigation of this complaint.
