
Dear Mr. Noble:

This letter is written to acknowledge the receipt of letters from the Federal Election Commission to our clients, Mark Brown, Fred Buro, Lawrence Mullin, Donald J. Trump, and Trump Hotels & Casino Resorts, Inc., relative to the receipt by the Commission of a complaint filed by Audrey L. Michael, dated May 18, 2000, which has been designated MUR 5020.


