As you know, State Senator Bill Gormley has been the leading advocate for the gaming industry at the state level for over the past ten years. He is currently running for the Republican candidacy for the U.S. Senate and has asked the gaming industry to contribute to his campaign. We both feel it is extremely important that we support Senator Gormley and would like each of you to consider making a donation to his campaign.

The Federal Election Campaign Act places limits on contributions to support candidates for federal offices. Under this Act, individuals are limited in the amounts they may contribute to candidates for federal office and to the political action committees (PACs) which support them. These limitations, referenced below, apply to any type of contribution, including contributions of money, goods and services, and loans:

1. An individual may give \$1,000 per election to each candidate for federal office. Primary elections, general elections, and runoff elections are considered separate elections. Therefore, an individual may give \$1,000 to a candidate for each election.
2. An individual may give \$5,000 to any political action committee per calendar year.
3. An individual may give \$20,000 to a national party committee. Each of the following is considered a national party committee: the party's national committee; its national House campaign committee, and its Senate campaign committee.
4. An individual may give a maximum of \$25,000 per year in total contributions.
5. A husband and wife each have separate contribution limits, even if only one spouse has an income. Therefore, a husband and wife may contribute a combined total of \$2,000 per election (\$1,000 each), as long as the check references both the husband and wife's name and both the husband and wife sign the check.

Checks should be made payable to "Gormley for Senate". We would like to hand deliver all the checks to Senator Gormley and are requesting that all checks be dropped off at Dave's office by Wednesday, March 29, 2000. Any help would be greatly appreciated.
