I. ACTIONS RECOMMENDED

Accept attached conciliation agreement, approve the appropriate letter and close the file.

II. BACKGROUND

On May 31, 2000, the Federal Election Commission (the "Commission") found reason to believe that Friends of Corrine Brown (the "Committee") and Gloria Simmons, as treasurer, violated 2 U.S.C. § 434(a)(6)(A) by failing to file 48-hour notices on contributions for the primary and general elections. The Commission also authorized the Office of General Counsel to enter into conciliation with the Committee prior to a finding of probable cause to believe, and approved a conciliation agreement to be sent to the Committee to resolve this matter.

III. DISCUSSION

Therefore, the Office of
General Counsel recommends that the Commission accept the proposed conciliation agreement
with Friends of Corrine Brown and Gloria Simmons, as treasurer, approve the appropriate letter,
and close the file in this matter.
