This is a referral of the Arab American Leadership Political Action Committee ("the Committee") for failure to file the 1998 July Quarterly and 1998 Year End Reports within thirty (30) calendar days from the date of the Non-Filer Notice. According to the 1997-1998 RAD Review and Referral Procedures for Unauthorized Committees further examination is required by your office.

The Committee was referred on September 30, 1999 for a possible 2 U.S.C. 438(b) audit covering the 1997-1998 election cycle. The Commission voted on October 19, 1999 not to audit the Committee (see RAD Referral #A99-77). Please note that the Committee met the priority review threshold with the filing of its 1998 October Quarterly Report.

- III. BACKGROUND:

Failure to Timely File the 1998 July Quarterly and 1998 Year End Reports

The Arab American Leadership PAC ("the Committee") failed to timely file the 1998 July Quarterly and 1998 Year End Reports of Receipts and Disbursements covering the periods from April 1, 1998 to June 30, 1998 and November 24, 1998 to December 31, 1998, respectively.

On December 29, 1997 and June 19, 1998 Prior Notices were sent to the Committee informing it that the 1998 July Quarterly Report was due on July 15, 1998 (Attachments 2 & 3).

A Non-Filer Notice was sent to the Committee via mailgram on December 28, 1998 referencing the 1998 July Quarterly Report (Attachment 4).

On December 29, 1997 and December 30, 1998, Prior Notices were sent to the Committee informing it that the 1998 Year End Report was due on January 31, 1999 (Attachments 2 & 5).

*All of the reports and amendments received on November 18, 1999 reflect an address of 1600 K Street, NW, Suite 501, Washington, D.C. 20006; however, no official request for an address change has been received.

On February 8, 1999, the Committee filed a 1998 Amended Year End Report; yet, no original 1998 Year End Report was submitted (Attachment 6).

On April 7, 1999, a Request for Additional Information ("RFAI") was sent to the Committee. The RFAI stated that the Commission had not received the Committee's original 1998 Year End filing, and advised the Committee that its report would not be considered complete until a Detailed Summary Page and all appropriate supporting schedules for the 11/24/98-12/31/98 period had been filed (Attachment 7).¹

On September 22, 1999, the Reports Analysis Division ("RAD") analyst called Ethel Ellis, the bookkeeper for the Committee, and told her that the Commission had not received the 1998 July Quarterly, 1998 Year End and 1999 reports, and that the matter may be referred to the Office of General Counsel. Ms. Ellis stated that she was working on amending all of the reports and was waiting to send in the missing reports since all of the figures would change as a result of the amendments. The analyst advised Ms. Ellis to send in the missing reports as soon as possible and to amend at a later date if necessary. Ms. Ellis said she would send the missing reports the next day (Attachment 8).

On November 3, 1999, the RAD analyst called Ms. Ellis and told her that the Commission had still not received the 1998 July Quarterly, 1998 Year End and 1999 reports, and again stated that this matter may be referred to the Office of General Counsel. Ms. Ellis stated that she was busy with other work responsibilities, but would come to the Commission on Monday, November 8, 1999 with the missing reports and amendments (Attachment 9).

On November 10, 1999, the RAD analyst called Ms. Ellis and told her that the Commission had still not received the 1998 July Quarterly, 1998 Year End and 1999 reports, and reiterated that this matter may be referred to the Office of General Counsel. Ms. Ellis stated that she would definitely come to the Commission on Monday, November 15, 1999 to meet with the analyst. She said that she had questions that needed to be answered before she could complete the missing reports. Ms. Ellis and the analyst agreed to meet on Monday, November 15, 1999 at 10:30 am (Attachment 10).

On November 15, 1999, the RAD analyst met with Ms. Ellis. She stated that she was working on the past due 1998 July Quarterly Report and discovered that the previous bookkeeper disclosed the activity for that period in the 1998

October Quarterly reporting period. She said that she was in the process of putting together the 1998 July Quarterly Report and would have it completed by Thursday. In addition, Ms. Ellis stated that the Committee had already filed the 1998 Year End Report and she showed a copy of this report to the RAD analyst. The RAD analyst informed her that the Commission never received this original filing, but did receive two amended 1998 Year End filings. Ms. Ellis gave the analyst a copy of the 1998 Year End Report and the analyst put it on the public record. Ms. Ellis stated that she would be filing amended reports along with the 1998 July Quarterly and 1999 reports on Thursday of this week (Attachment 11).

On November 18, 1999, the Committee filed the 1998 July Quarterly Report, the 1999 Mid-Year Report, and several amendments for calendar year 1998 reporting periods (Attachment 12).


