GENERAL COUNSEL'S REPORT #2

I. ACTIONS RECOMMENDED

Accept the attached signed counter-proposed conciliation agreement and close the file in these matters.

II. DISCUSSION

In MUR 5028, the Commission found reason to believe that the above-referenced Respondents violated 2 U.S.C. § 434(a)(4)(A)(i) by failing to timely file their 1998 July Quarterly Report and 1998 Year End Report. In MUR 5054, the Commission found reason to believe that Respondents violated 2 U.S.C. § 434(a)(4)(A)(iv) by failing to timely file their 1999 Mid-Year Report. On July 21, 2000, the Commission approved a proposed conciliation agreement addressing both MURs prior to a finding of probable cause to believe.

Accordingly, this Office recommends that the Commission accept the attached signed conciliation agreement with the Arab American Leadership Political Action Committee and James Joseph Zogby, as treasurer, and close the file in these matters.

III. RECOMMENDATIONS


1. Accept the attached signed conciliation agreement with the Arab American Leadership Political Action Committee and James Joseph Zogby, as treasurer.
