The Bob Greenlee for Congress Committee ("the Committee") has failed to file or timely file 48-Hour Notifications for contributions totaling \$30,000.66 received prior to the 1998 General Election. According to the 1997-1998 Reports Analysis Division Review and Referral Procedures for Authorized Committees an examination by your office is required.

Robert-D. Greenlee lost the 1998 General Election for the House of Representatives in Colorado receiving forty-seven percent (47%) of the vote.

- III. BACKGROUND:

The Bob Greenlee for Congress Committee ("the Committee") has failed to file or timely file 48-Hour Notifications ("48-Hour Notices") for contributions totaling \$30,000.66 received prior to the 1998 General Election.

The candidate was involved in the 1998 Colorado General Election held on November 3, 1998. Prior Notice was sent to the Committee on September 30, 1998 (Attachment 2). The Notice includes a section entitled "48 Hour Notices on Contributions." This section reads: "Notices are required if the committee receives contributions (including in-kind gifts or advances of goods or services; loans from the candidate or other non-bank sources; and guarantees or endorsements of loans to the candidate or committee) of \$1000 or more, during the period October 15 through October 31. The notices must reach the appropriate federal and state filing offices within 48 hours of the committee's receipt of the contribution(s)."

On February 2, 1999 a Request for Additional Information ("RFAI") was sent to the Committee (Attachment 4). The RFAI notes on an informational basis that the Committee may have failed to file one or more of the required 48-Hour Notices for "last minute" contributions of \$1,000 or more. The notice requests the Committee to review their procedures for checking contributions received during the aforementioned time period. In addition, the notice states that although the Commission may take legal action, any response would be taken into consideration.

The Committee's February 16, 1999 response states that the 48-Hour Notice discrepancy occurred due to an "oversight" on the part of the assistant treasurer (Attachment 5).

WHO MUST FILE

All 1998 general election principal campaign committees of congressional candidates (including unopposed candidates) who seek election in the November 3, 1998, General Election must file the Pre- and Post-General Election Reports. If the campaign has an authorized committee(s), in addition to the principal campaign committee, the principal campaign committee must also file a consolidated report on Form 3Z and attach the report(s) of the authorized committee(s).

48 HOUR NOTICES ON CONTRIBUTIONS

Notices are required if the committee receives contributions **(including in-kind gifts or advances of goods or services; loans from the candidate or other non-bank sources; and guarantees or endorsements of loans to the candidate or committee)** of \$1,000 or more, during the period October 15 through October 31.

The notices must reach the appropriate federal and state filing offices within 48 hours of the committee's receipt of the contribution(s). U.S. House candidates faxing 48-hour notices should transmit them to the FEC at 202/219-0174. Senate candidates should transmit them to the Secretary of the Senate at 202/224-1851. Note that 48-hour notices are the only FEC documents that may be faxed.

*These dates indicate the beginning and the end of the reporting period. A reporting period always begins the day after the closing date of the last report filed. If the committee is new and has not previously filed a report, the first report must cover all activity that occurred before the committee registered.

** Reports sent by registered or certified mail must be postmarked by the mailing date; otherwise, they must be received by the filing date.

-Schedule A of your report discloses a contribution(s) which appears to exceed the limits set forth in the Act (copies attached). You should examine all of your contributions to check for additional excessives. The Committee's procedures for processing contributions should also be reviewed.

An individual or a political committee other than a qualified multicandidate committee may not make a contribution to a candidate for federal office in excess of \$1,000 per election. A qualified multicandidate committee and

This letter is in reference to your inquiry dated February 2, 1999. It is relating to questions you have concerning our 30-Day Post General Report. I will address all of your questions in order as they were given to me.

Regarding the 48 Hour Notice I filed for the 'Citizens for Political Accountability' contribution of \$1,000 on 10/20/98. You noted that this did not appear on our schedule A. It actually does but under a slightly different name. The full name of the PAC that sent us the above contribution is the 'Cracker Barrel Old Country Store - Citizen's for Political Accountability PAC'. It was on our schedule A under the abbreviated name of 'Cracker Barrel Old Country Store CPA PAC'.

In regards to the contributions that appeared to exceed the limits. Enclosed you will find the amended pages on schedule A that address the contributions that were in question. I mistakenly entered into our computer software that \$450 contribution from Ed Lehman and the \$450 contribution from Ruth Lehman, both on October 20th, that they should be attributable to the General election. That was incorrect, in both instances the contributions should have been attributed to the Primary election for that is what they requested.

In regard to failing to file 48 Hour reports, prior to the General election. Upon a review that was prompted by your letter, it has come to my attention that I inadvertently failed to file reports for several contribution received within the 20 day pre-general election time period. I apologize for overlooking them, and any problems that my oversight might have incurred on anyone. Listed below are the contributions that I inadvertently missed during the 48-Hour filing time period, although they are on our schedule A, in our 30-day Post General Election report.


