Dear Ms. Boyt:

This is in response to the Federal Election Commission's letter of June 22, 2000 regarding MUR 5031. We ask that this matter be dismissed with respect to UNITE - PEC and that the Commission take no further action.

The complaint includes one paragraph that alleges that UNITE – PEC gave a contribution to the 17th District Victory Fund for the benefit of Lane Evans and thereby made an excessive contribution. Complaints are merely rehashing old ground and disingenuously fail to include the correspondence UNITE – PEC had in 1999 with the FEC that resolved this matter.

In February 1999, UNITE – PEC received a Request for Additional Information from the Reports Analysis Division asking UNITE – PEC to clarify whether its \$3,000 contribution to the 17th District Victory Fund “was an earmarked contribution... or if you made the contribution to the political committee exercising no direction or control over how the funds were to be used.” UNITE – PEC responded in a letter dated March 9, 1999, that the contribution was not earmarked for a particular candidate and that UNITE – PEC did not “exercise any control over how the contribution in question was used by the 17th District Victory Fund.” Copies of this exchange of correspondence are attached to this letter.



UNITE – PEC filed an amended report to correct the administrative error that had originally been made giving rise to this question. The notation originally on the report was merely an administrative notation of who was responsible for soliciting the contribution for the party committee. UNITE – PEC gave the contribution with the full understanding that it would be used for the overall efforts of the 17th District Victory Fund and that the funds would be used by the Fund in its discretion.

UNITE – PEC heard nothing more from the FEC on this matter. This is the correct result in response to this complaint, as well. UNITE – PEC made a legal contribution to a local party committee, not earmarked or controlled in any way by UNITE – PEC. There was no violation of the campaign laws, and this matter should be dismissed.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule B supporting Line 23 of your report discloses a contribution to the 17th District Victory Fund; however, you have disclosed "Transfer Lane Evans, Illinois 17th District" in the purpose of disbursement field. Please clarify whether this was an earmarked contribution made by your committee through the 17th District Victory Fund to this candidate, or if you made the contribution to the political committee exercising no direction or control over how the funds were to be used.

-For future reporting, please be advised that only contributions to federal candidates and political committees should be itemized on a separate Schedule B supporting Line 23 of the Detailed Summary Page. Contributions to non-federal candidates and committees should be itemized on Schedule B supporting Line 29.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. 
The purpose of this letter is to respond to your letter dated February 3, 1999, regarding Chicago & Central States UNITE PEC's (hereinafter "the Committee") \$3,000 contribution to the 17th District Victory Fund as reflected on the Committee's 1998 12 Day Pre-General Report.

The Committee's 10/7/98 contribution to the 17th District Victory Fund, a party committee, was not earmarked as a contribution to a particular candidate nor did the Committee exercise any control over how the contribution in question was used by the 17th District Victory Fund. Due to an administrative error, the purpose of the contribution was reported as a "transfer Lane Evans, Illinois 17th District". That description of the contribution was incorrect. The contribution should have been described as a "contribution" to the 17th District Victory Fund for 1998.

We have amended the Committee's 1998 12 Day Pre-General Report to describe the purpose of our contribution to the 17th District Victory Fund correctly. A copy of the amended report is appended hereto.
