The Committee was referred for a possible 2 U.S.C. 438(b) audit covering the 1997-98 election cycle. The Commission voted on October 19, 1999 not to audit the Committee (see RAD Referral #A99-78).

## III. BACKGROUND:

## Chronic Late Filing of Reports

The Loose Group ("the Committee") has failed to file three (3) Reports of Receipts and Disbursements in a timely manner for the 1997-1998 election cycle (see chart on page 3). The reports were filed between twenty-four (24) and thirty-five (35) days late.

On August 22, 1997, the Committee provided a cover letter with its 1997 Mid-Year Report that states, "[D]ue to a change in staff, we were unaware of the required reports on the appropriate dates" (Attachment 5).

On March 27, 1998, a Chronic Late Filer Notice was sent to the Committee for failing to file the 1997 Mid-Year and Year End Reports in a timely manner (Attachment 9). The Notice advised the Committee that any additional late filing of reports may result in legal enforcement action.

On April 9, 1998, the Committee provided a cover letter with its 1998 April Quarterly Report. The letter states, "We have had a problem with our bank

statements being received on a timely fashion and have a new administrative volunteer. We are rectifying the problem by moving our account to a new bank and signing up for the electronic filing" (Attachment 10).

Subsequent to the sending of the Chronic Late Filer Notice, the Committee failed to file the 1998 30 Day Post-General Report in a timely manner.
