I. ACTION RECOMMENDED

Accept the attached signed Conciliation Agreement with The Loose Group and Frank G. Stevenson, as treasurer.

II. BACKGROUND

This matter was generated based on information ascertained by the Federal Election Commission ("the Commission") in the normal course of carrying out its supervisory responsibilities. See 2 U.S.C. § 437g(a)(2). On July 13, 2000, the Commission found reason to believe that The Loose Group and Frank G. Stevenson, as treasurer, violated 2 U.S.C. §§ 434(a)(4)(A)(iii) and (iv). On July 19, 2000, this Office notified the Respondents of the Commission's finding and enclosed the approved Conciliation Agreement


A check for \$2,100 has been received. This Office recommends that the Commission accept the attached conciliation agreement.

1. Accept the signed Conciliation Agreement of The Loose Group and Frank G. Stevenson, as treasurer.
2. Approve the appropriate letters.
3. Close the file.
