


As you can see, I have filed complaints with both entities. The response from the American Legion is attached; I have had no response from the corporation.

I have been in contact with the editor of the American Legion magazine regarding your company ad in that publication for the last few issues.

I am attaching correspondence with the magazine which is self explanatory, and a copy of the referenced ad. The editor dismisses my complaint with his comment that the ad refers to the elder Bush, though most readers will not and cannot see that distinction. It is illegal for corporations to sponsor political ads; and I maintain that this ad falls into the political field.

I would appreciate your changing your ad to a strictly non-partisan copy. If the ad continues as written in the next issue, then it is my intention to file a formal complaint with Federal election officials against your company and the American Legion magazine.

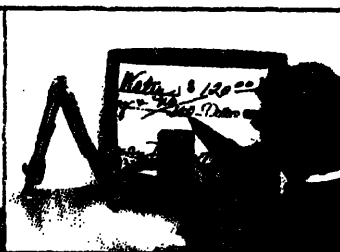

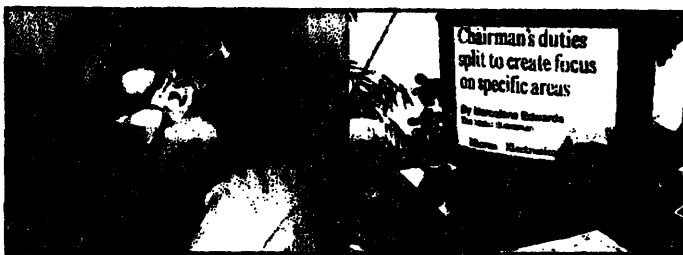
