GENERAL COUNSEL'S REPORT # 2

I. ACTIONS RECOMMENDED

Accept the attached signed counter-proposed conciliation agreement and close the file in this matter.

II. DISCUSSION

In MUR 5078, the Commission found reason to believe that Friends of Joe Baca and Joe Baca, as treasurer (the "Committee") violated 2 U.S.C. §§ 441a(f), 441b(a), 434(a)(6)(A), (b)(4) and (b)(8) by accepting an excessive contribution, accepting three prohibited corporate contributions, omitting 48-Hour Notices for six contributions, omitting the description of the purpose of disbursements on three reports and omitting Schedule Ds on two reports.

On May 1, 2001, the Commission approved a proposed conciliation agreement prior to a finding of probable cause to believe. The proposed conciliation agreement approved by the Commission provided for a civil penalty
