GENERAL COUNSEL'S REPORT #3

I. ACTIONS RECOMMENDED: Approve the attached signed conciliation agreement.

II. BACKGROUND

On November 7, 2000, the Commission found reason to believe that Missouri Democratic State Committee and Donna Knight, as treasurer (the "Committee") violated 2 U.S.C. § 441a(f) of the Federal Election Campaign Act of 1971, as amended (the "Act") for receiving excessive contributions; and the Commission's regulations at 11 C.F.R. § 102.5(a) for failing to properly allocate expenditures, and refunds and rebates between its federal and non-federal accounts. On that same day, the Commission decided to enter into pre-probable cause conciliation with the Committee in an effort to settle the matter prior to a finding of probable cause to believe.¹

III. DISCUSSION OF CONCILIATION

¹ On December 14, 2000, the Commission made a final determination that the Committee must pay a \$6,800 administrative fine for the late filing of its July 2000 quarterly report. The Committee paid the \$6,800 administrative fine on February 2, 2001. See AF# 48. The administrative fines matter is unrelated to the subject Report.


