Response to Complaint

In accordance with 2 U.S.C. § 437g(a), Friends for a Democratic White House ("FDWH") submits this response through its legal counsel in response to letters to the Federal Election Commission ("FEC") dated November 27, 2000 and December 12, 2000 from Gore 2000 ("Complaint").

**FACTUAL SUMMARY**

By a letter dated November 27, 2000, the FEC provided notice to FDWH of a Complaint filed by Gary R. Gruver, on behalf of Gore 2000, Inc. The complaint had, as attachments, two letters on FDWH letterhead dated October 18, 2000. The first letter was directed to Carolyn Utrecht at Bethesda, MD 20814, and the second to Eric F. Kleinfeld at Washington, D.C. 20009. A true and complete copy of the complaint with Exhibits is attached hereto as Exhibit A.

The Complaint sets out three basic violations. First, that FDWH conducted a solicitation for contributions "to a name available only on the committee's (Gore) FEC report. In addition, the names of other recipients, while possibly available elsewhere can logically only have come from being copied directly from the committee's FEC report." Compl. at 2. The name cited in the complaint is one "Carolyn Utrecht". In essence the complaint claims that the name Carolyn Utrecht could only have come from contributor information on file with FEC records.

The second count in the Complaint alleges that FDWH failed to register as a political committee as required by 2 U.S.C. § 433(a) and 11 C.F.R. § 102.1, and file disclosure reports pursuant to 2 U.S.C. § 434(a) and 11 C.F.R. § 104.1. Compl. at 3.

The third count makes a general allegation that the FDWH representation regarding inaugural ball tickets to the Gore inaugural ball is a fraudulent misrepresentation in violation of 2 U.S.C. § 441h.

By letter dated December 12, 2000, the FEC forwarded to FDWH additional materials received from the Gore 2000 committee supplementing the original Complaint and providing new allegations. This supplemental information claimed one "Jeannette [sic] Hensler, the treasurer of FDWH," should be listed as an additional respondent. The other information contained in this letter were newspaper articles and a FDWH fundraising letter dated November 17, 2000, which had the addressee's identification blacked out—presumably by complainant. A true and complete copy of this supplemental information is attached hereto as Exhibit B.

FDWH is a political committee registered with the FEC. FDWH filed a Statement of Organization on November 6, 2000 listing Jeannette Hensler of Holt, MI 48842 as its treasurer. FDWH is registered as a committee which supports or opposes more than one federal candidate and is not a candidate or party committee. Subsequent amendments of the Statement of Organization have been filed, including an amendment naming Patricia Claucherty as the new treasurer. The committee's ID number is C00363390. The committee's Statement of Organization and amendments are attached as Exhibit C. FDWH has also timely filed disclosure reports in accordance with 2 U.S.C. § 434. A summary of these filings is attached hereto as Exhibit D.

### **DISCUSSION AND LEGAL ANALYSIS**

#### **A. Contrary to Allegations in the Complaint, FDWH is a Registered Committee Which has Timely Filed its Statement of Organization and Disclosure Reports.**

The second count of the Complaint alleges FDWH has failed to register as a political committee. Documents on file with the Commission and attached hereto clearly indicate that there is no basis for this allegation. The committee was a registered committee as of November 6, 2000. Exhibit C. The committee has timely filed all disclosure reports mandated by 2 U.S.C. § 434 and 11 C.F.R. § 104.1. Exhibit D.

Based on this information, FDWH has not violated the registration or reporting requirements of the FECA.

#### **B. FDWH was not an Agent of the Gore 2000 Campaign and Therefore there is No Basis Upon Which to Allege a Violation of 2 U.S.C. § 441h.**

The third count of the Complaint makes an effort to allege that FDWH was acting in the capacity of an agent when it made representations of providing inaugural ball tickets to selected contributors. Somehow, the complainant claims that by acting as an agent for Gore 2000, FDWH violated 2 U.S.C. § 441h. FDWH was not acting as an agent for Gore 2000. FDWH was not purporting to act as an agent of Gore 2000. FDWH is not and did not hold itself as federal candidate or as an agent for a federal candidate.

Section 441h provides:

“No person who is a candidate for federal office or an employee or agent of such candidate shall—

- (1) Fraudulently misrepresent himself or any committee or organization under his control speaking or writing or otherwise acting for or on behalf of *any other* candidate or political party or employee or agent thereof on a matter which is damaging to such other candidate or political party or employee or agent thereof...

2 U.S.C. §441h(1) (emphasis added).

The Complaint states "by promising to award inaugural ball tickets to Al Gore's inaugural ball, this group is holding itself out as an agent of Al Gore when, in fact, it is not. By falsely holding itself out as an agent, the group is acting in a manner damaging to both Al Gore and his principal campaign committee, since the latter could be accused of wrongdoing under the act based on the fraud of this group." Compl. at 3.

First, FDWH is neither an agent of a candidate for Federal office nor a candidate for federal office itself. Exhibit C. As its Statement of Organization indicates, it is a multi-candidate political committee. *Id.* Therefore, regardless of its conduct, it cannot be subject to the plain language of § 441h.

Second, FDWH is not an agent for Gore 2000 and has never held itself as an agent of Gore 2000. The FDWH statement of organization clearly indicates that it is not an authorized committee of Gore 2000. Rather, it is a multicandidate committee. Exhibit C. In support of this, the FDWH, in an October 18, 2000 letter, attached to the Complaint solicits contributions up to the five thousand dollar (\$5,000.00): the maximum permitted for a multicandidate committee but not the one thousand dollar (\$1,000.00) limit for an authorized committee. *Compare* 2 U.S.C. §441a (a)(1)(C) *with* 2 U.S.C. § 441a(a)(1)(A).

In order to be considered an "agent" the Gore 2000 committee would have to authorize FDWH to act on its behalf. RESTATEMENT (THIRD) OF AGENCY, § 1.02 (2000) ("[A] person manifests consent or intention through written or spoken words or other conduct if the person has notice that another will infer such consent or intention from the words or conduct."). FDWH cannot unilaterally classify itself as an agent of Gore 2000, Inc. and impute liability to Gore 2000, Inc. without the authorization of Gore. RESTATEMENT (THIRD) OF AGENCY, § 1.01 (2000) (explaining that the principal must authorize its agent to act on its behalf). Therefore, by the very admissions in the Gore 2000 Complaint, the agency argument must fall.

"Neither the committee or Al Gore have any connection with or knowledge of this organization or its Chief of Staff. Neither the committee nor Al Gore have authorized its activities or have had any communications whatsoever with this organization or its Chief of Staff. This organization is also not connected to any future inaugural committee for Al Gore." Compl. at 2.

In view of the fact that FDWH is neither an agent nor has it been given any authority whatsoever by Gore 2000 to act on its behalf, the allegation that FDWH is an agent for purposes of a 441h violation fails to be supported by any factual or legal basis.

In addition, 441h is premised upon activities which are "damaging to another candidate or political party." No information contained in the text of the letter can be construed as being "damaging" to another candidate, political party employee or agent thereof. These solicitation letters merely request contributions to support Gore, and if successful, to award inaugural ball tickets to selected contributors. The Commission is well aware that in the event Mr. Gore had been successful in the election, his inaugural ball committee (as with all such inaugural committees in the past) merely offer for sale, issue and deliver tickets for the inaugural balls.

There is not a prohibition on the resale or, the gifting of those tickets. Rather it is a common practice that those original ticket holders are able to pass on such inaugural tickets as gifts or through reimbursement deliver to third parties. Realistically, the ball tickets are available to the general public either as gifts or for purchase. Therefore, merely offering the ball tickets does not by any stretch contend to be a "damaging" message, implied or tacit, to the Gore 2000 committee. Furthermore, FDWH has contributed \$20,000 to the Democratic National Committee, \$15,000 to state Democratic parties, and \$1,000 to Gore Lieberman, Inc. See Exhibit E, 2000 Post Election Report Form 3X and Schedule B. In other words, FDWH has raised and contributed money for the exact causes supported by Gore 2000.

**C. The Complaint Fails to Provide any Substantiation that FDWH Obtained the Contributor Names at Issue From the FEC Disclosure Records.**

Finally the Complaint alleges that FDWH violated 2 U.S.C. § 438(a)(4) by soliciting contributions from two (2) specified individuals whose name could only have been secured by FDWH from contributor disclosure records on file with the FEC. Compl. at 2.

Contrary to the allegations in the Complaint, there are no facts presented to substantiate such an allegation. Complainant suggests that simply because a name appears on an FEC report it cannot be obtained in a different manner. A simple example demonstrates that this is not true.

For example, there are commercial vendors that offer FEC contributor information. One such commercial source is Votenet Solutions, Inc. It can be located on the internet at [www.tray.com](http://www.tray.com). Exhibit F. In the left hand column of [www.tray.com](http://www.tray.com), under FEC info database queries, there is a category for "U.S. Presidential Candidate Money" with a subcategory of "1999-2000". *Id.* If one clicks on that link, a list of the Presidential candidates appears. Exhibit G. On that screen, one can scroll to Gore 2000. One can then select a particular reporting period—for example the first quarter of 1999. Clicking on that first quarter of 1999 will bring up the list of states with aggregate contributor information; number of contributors and total contributions received from the state. Exhibit H. Selecting "Maryland" brings a list of all contributors to Gore 2000 for that quarter, whose address is in Maryland. Exhibit I. The list is available with 200 names at a time. Clicking the final 200 selects names containing "U". Exhibit J. Please note that the list of contributors at this site consists of not only names, addresses, cities and states but also occupation, employer, date of contribution and amount of contribution. Going to page 5 of that contributor listing, please note the name of "Carolyn Utrecht" at Bethesda, MD 20814. The listing of her occupation is as an attorney at the law firm of Ryan, Phelps, Utrecht *et al.* It reflects a one thousand dollar (\$1,000.00) contribution being made on February 16, 1999. This is the very name—Carolyn Utrecht not Lyn—and her full address, Bethesda, MD 20814—which the Complaint alleges can only be access from disclosure information on file with the FEC. The contention in the Complaint is obviously not correct, given this exact information located on a commercial web site.

It is important to note that this Votenet site is a commercial venture and does not contain anywhere within the site a warning or notice of any type that this information is precluded by the FECA from being utilized by those viewing it. See Exhibits F-J. The standard notice of

disclaimer required by 2 U.S.C. § 438 is not contained on this website. The notice at the top of FEC Schedule A of Form 3X, which is included on the FEC's imaging of contributor's records, states, "any information copied from such reports and statements may not be sold or used by an person for the purpose of soliciting contributions or for commercial purposes other than using the name and address of any political committee to solicit contributions from such committee." No such warning, or notice containing that language or any language whatsoever restricting the use of this information appears on the Votenet site.

Similarly, with regard to the name of Mr. Kleinfeld, if one follows the same steps as noted above, and clicks on the District of Columbia for the first quarter of 1999, the name of "Mr. Eric Kleinfeld" appears on the list (from the 100-199 group list). Exhibit K (page 8 of 9). It is listed as Eric F. Kleinfeld, Washington, D.C. 20009. He is an attorney with the law firm of Ryan, Phillips *et al.* The contributor information reflects a one thousand dollar (\$1,000.00) contribution being made on February 1, 1999 and a second one thousand dollar (\$1,000.00) contribution being made on March 23, 1999.<sup>1</sup> Again, this the precise name and complete address which is alleged in the Complaint to have only been available from disclosure reports on file at the FEC.

This information likewise evidences that there is no factual basis for that claim, since the Votenet commercial site, is the source for the identical type of information. Clearly, and contrary to the accusations in the Complaint, the FEC public disclosure records *are not* the only source from which the name of Carolyn Utrecht or Eric F. Kleinfeld, can be obtained. The facts are rather simple: the names of Carolyn Utrecht and Eric F. Kleinfeld appear on the Votenet records, the Votenet site is not an FEC site, and that those records fail to list any notice or warning against the FECA prohibition for the use of such information for solicitation of contributions or other commercial purposes. This evidences that the FDWH source for its solicitation address could be obtained from sources other than the FEC disclosure records.

The statutory prohibition at 2 U.S.C. § 438(a)(4), which is the basis upon which this portion of the Complaint is founded, is limited in its applicability to the reports and statements which are actually on file with the Commission. Therefore, FDWH cannot be considered to have violated that provision of the FECA. Coupled with that is the fact that the site at Votenet, as noted above, fails to provide any notice of the 2 U.S.C. § 438(a)(4) notice and warnings. Absent such warnings, it is not reasonable that the FEC could impute liability to any organization, whether it be a political committee or a commercial operation, from utilizing the materials at such a site.



<sup>1</sup> FDWH notes to the Commission that the aggregate of two thousand dollars (\$2,000.00) in contributions by Mr. Kleinfeld may possibly constitute an excessive contribution in violation of 2 U.S.C. § 441.

**CONCLUSION**

For these reasons, FDWH respectfully submits that there is no factual legal basis to move forward with this Complaint. The Commission should make a finding of no reason to believe and close the file.

This complaint is hereby filed with the Federal Election Commission (the "FEC" or "Commission"), because one or more persons or sham groups has allegedly stolen the list of contributors of Gore 2000, Inc. (the "Committee") and is currently engaged in a fraudulent misrepresentation of the Committee and its candidate. The Commission should immediately investigate these crimes and violations of the Federal Election Campaign Act (the "Act") and take swift and decisive steps to stop this action and punish those who have committed these violations.

**RESPONDENTS**

This complaint is filed against the "Friends for a Democratic White House" with an address of 2020 Pennsylvania Avenue, NW, #801, Washington, DC, 20006 and 2020 Pennsylvania Avenue, NW, PMB 801, Washington, DC 20077-8620; J. Dewald, the Chief of Staff of this organization at the same addresses; and any other participant or conspirator, as determined by the Commission in its investigation, in these violations (the "respondents").

For notification purposes, the Commission should use the latter address listed above. A representative of complainant visited the purported offices of this sham group, and it turned out to be a "Mailboxes, Etc."

**COMPLAINANT**

This complaint is being filed by Gore 2000, Inc., Gary R. Gruver, Assistant Treasurer 601 Mainstream Drive, Nashville, Tennessee 37228.

**DISCUSSION**

Attached to and incorporated in this complaint are copies of a fundraising letter purporting to raise \$1 million to pay for activities in support of the Democratic candidate for President, Al Gore. The solicitor claims to be a "PAC", yet there are no registrations or reports on record at the Commission. The solicitor claims to have a "select" mailing list, yet it has obviously mailed names off of the Committee's list and names that could have come only from the Committee's list or FEC reports.

In return for a contribution of up to \$5,000, the solicitor promises to award certain randomly selected contributors pairs of tickets to the "Al Gore Inaugural Ball in Washington DC". The solicitation is signed by a J. Dewald, who purports to be the chief of staff of the PAC.

Neither the Committee nor Al Gore have any connection with or knowledge of this organization or its chief of staff. Neither the Committee nor Al Gore have authorized its activities or have had any communications whatsoever with this organization or its chief of staff. This organization is also not connected to any future inaugural committee for Al Gore.

Instead, there is clear reason to believe that this is a sham organization intended not for the purpose of engaging in political activity, but rather for the obvious purpose of swindling unsuspecting Democratic supporters out of their personal funds. There is no record of any previous political activity by this group, and its address is nothing more than a mailbox rented at a Washington, DC "Mailboxes Etc.", obviously rented for the sole purpose of bilking donors. The Commission should note that the date of this solicitation ensures that any money received would be so received after the close of the books for the required pre-general report of receipts and disbursements, and so late that any money received would likely not come in until after election day, let alone in time to be spent to influence the election in any meaningful way. In addition, complainant is not aware of any 48 hour notices being filed to date, further indicating the fraudulent purposes of this mailing and their clear lack of any intent to comply with the law.

### **VIOLATIONS**

A number of violations of the Act have been committed by this sham group, as follows.

**1. This sham organization has illegally copied complainants' FEC report.**

The Act provides that information copied from FEC reports or statements may not be sold or used by any person for the purpose of soliciting contributions or for commercial purposes. 2 U.S.C. §438(a)(4). Upon information and belief, respondents have sent their purported solicitation to a name available only on the Committee's FEC report. In addition, the names of other recipients, while possibly available elsewhere, can logically only have come from being copied directly from the Committee's FEC report.<sup>1</sup> Upon information and belief, the only persons who have received this mailing are persons on the Committee's FEC reports. The Committee's contributor list has not been marketed or otherwise been made available. Accordingly, the Commission should investigate and find that respondents have violated 2 U.S.C. §438(a)(4).

<sup>1</sup> The recipient of the attached letter is "Carolyn" Utrecht. As the Commission is aware, Ms. Utrecht is known commonly as "Lyn" and is rarely referred to as Carolyn. The Committee, however, listed her as Carolyn on its reports as a protective measure.

**2. This purported PAC has failed to register with and report to the Commission.**

The Act requires that any group of persons that receives contributions aggregating in excess of \$1,000 or makes expenditures aggregating in excess of \$1,000 during a calendar year to register with the Commission and report its receipts and disbursements. 2 U.S.C. §431(4), §433, and §434. Clearly, respondents by the language of their own letter intend to raise and spend over \$1,000. In fact, they may have already done so. Upon information and belief, the Committee's direct mail fundraising letters to its own donors would exceed \$1,000 in costs. If respondents sent this letter to all of the Committee's contributors – as it appears has been done – the costs would thus exceed the amount necessary to register and report. Accordingly, the Commission should investigate and find that respondents have violated 2 U.S.C. §431(4), §433, and §434.

**3. This sham organization is fraudulent misrepresenting itself to the Committee's contributors.**

The Act provides that no person who is an agent of a candidate shall fraudulently misrepresent himself as speaking, writing or acting on behalf of another candidate or agent in a damaging manner. 2 U.S.C. §441h. By promising to award inaugural ball tickets to Al Gore's inaugural ball, this group is holding itself out as an agent of Al Gore (when, in fact, it is not). By falsely holding itself out as an agent, the group is acting in a manner damaging to both Al Gore and his principal campaign committee, since the latter could be accused of wrongdoing under the Act based on the fraud of this group. Accordingly, and upon information and belief, the Commission should investigate and find that respondents have violated 2 U.S.C. §441h.

**CONCLUSION**

The activities undertaken by respondents, including the fraud being perpetrated on unsuspecting supporters of Al Gore, must be stopped. The Commission should act swiftly and decisively to investigate these matters and punish any possible wrongdoing that has occurred. In the absence of such Commission action, the integrity of the reports filed will be compromised and any contributor, no matter their affiliation, will be left to fend off similar non-political fraudulent activities. Candidates and their committees will be left to defend their names from being used in similar despicable and unauthorized manners. Therefore, complainants respectfully request that the Commission step in and take action.


- 1) We hereby allege that an additional respondent has participated in the illegal scheme and committed the violations described in our original complaint. That respondent is Jeannette Hensler whose address is Holt, Michigan 48842. We have attached a statement of organization and newspaper article containing this information for the Commission's information.
- 2) The newspaper article referred to in the paragraph above describes the facts included in our original complaint and should be considered a part thereof.
- 3) In addition, subsequent to the filing of our original complaint, respondents have sent out a second mailing for apparently fraudulent purposes. A copy of this second mailing has been attached hereto. Accordingly, we reallege all of our original allegations with respect to this second mailing. Further, because the violations are of an ongoing nature, we allege that they are knowing and willful, and we respectfully request that the Commission make such a finding of knowing and willful violations of the Act.

The activities undertaken by respondents, including the fraud being perpetrated on the unsuspecting supporters of Al Gore must be stopped. The seriousness of these violations should compel the Commission to act swiftly and decisively to investigate these matters and punish the wrongdoers. If this activity is permitted to continue, the

complainant is likely to suffer irreparable harm, and complainant's supporters are likely to be bilked out of thousands of dollars for unlawful purposes. The Commission has the utmost duty to the public and to the integrity of the disclosure process to step in and prevent this illegal activity from occurring.



## 'Swing States PAC' Probed

"It was a hard fought battle, but with your support, the Presidency was captured for the Republican Party and George W. Bush this year. Now our opponents want to use the legal system to steal the election."

So begins a Nov. 18 solicitation for the "Swing States PAC" Legal Challenge Fund mailed to Republican givers. A letter dated just a day earlier mailed to Democratic contributors by "Friends for a Democratic White House" is nearly identical, except it insists the presidency "was captured for the Democratic Party and Al Gore this year."

The letters are popping up in mailboxes in Washington, Connecticut, Michigan and elsewhere, urging a contribution of "at least \$1,000," to be mailed in postage-paid envelopes to seemingly prestigious Pennsylvania Avenue addresses, one near the Capitol, the other a few blocks from the White House. Both are signed by a "J. Dewald," who claims the title "Chief of Staff."

So far, the envelopes aren't going to lawyers for Bush and Gore-- they are going to mail drops at Mail Boxes Etc. on Pennsylvania Avenue. As of late yesterday, the letters and the person who rented

he said, explaining that people sometimes use mail drops "to make it look like they have a legitimate suite of offices." Mihalko said the postal service knows who rented the mail drops, and said the person did present identifying information when he did so.

An FBI official in Michigan said late yesterday that the letter campaign was under investigation. "We've opened up a case; we're looking into it," said FBI official Kevin Brock.

The manager of Mail Boxes Etc. at 2000 Pennsylvania Ave. refused to discuss the mail drop there, saying the customer had filled out a postal service form authorizing him to receive mail through an agent. The form guarantees privacy to box holders at post offices and private mail drop operations.

Whoever is sending the letters isn't quite double-checking his lists, however. A couple in Darien, Conn., contacted state Attorney General Richard Blumenthal Monday after getting one of each variety. Blumenthal, a leading Democrat in Connecticut, had already gotten one himself.

"My visceral reaction was to think it was legitimate--you receive these letters every other week asking for money," he said yesterday. "The thing that set off alarm bells for me was I didn't recognize the name, J. Dewald. And the title, chief of staff--it just didn't sit right." His office began investigating Monday.

The fact that the same letters were sent to contributors in both parties "is a pretty strong indication of fraud," said Blumenthal. In addition, in Connecticut, PACs and charities must be registered to solicit funds legally, something these groups did not do, said Blumenthal.

The two PACs did register with the Federal Election Commission, filing forms that list mailing addresses in Michigan. The Republican group lists Jennifer Vavricka of Morrice, Mich., as treasurer; the Friends for a Democratic White House lists Jeanette Hensler of Holt, Mich. Neither woman could be reached yesterday.

"They do have a Bush-Cheney sign up in their yard," said Ada Smith, a neighbor who lives across the street from Hensler, treasurer of the Democratic group. Smith, who received several calls from reporters trying to contact Hensler, said she went across the street to urge Hensler to answer questions about the fundraising group but she refused.

The postal inspector's office began a preliminary investigation yesterday

to determine whether the fundraising letters constitute mail fraud. The Bush campaign complained to the postal service several weeks ago about another "Swing States PAC" solicitation letter that promised tickets to the inaugural. The Gore campaign complained to the FEC about a similar letter.

"The Postal Service is trying to determine whether the Postal Service or the Federal Election Commission should investigate," said Mihalko. "At this point, it's not determined whether we would pursue this criminally or civilly. We're looking at it to determine whether we have a viable mail fraud case."

The letters say the cost of legal challenges in the election battle in Florida would cost each side \$3 million to \$5 million. They include "notices and disclaimers required by the Federal Elections Commission and/or the Internal Revenue Service," and include the admonition that corporate donations are not permitted and that individual contributions are limited to \$5,000.

They do promise a little something in return: "limited edition" coffee mugs "certain to become a valuable collector's item in the years to come following this unprecedented election." And there's even a place to request an e-mail alert as soon as it is shipped out.

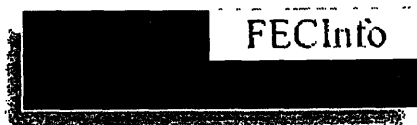


